E. Discussion & Vote of FY23 Short Cycle Funding Application to be submitted to CYFD Jeremias introduces the Short Cycle Funding Application with a brief overview and turns it over to Noelle for specific comment

Noelle: Begins by saying they have gone through more than 50% funding and are requesting additional funding by way of this Short Cycle Funding application.

Noelle continues by giving specific numbers for attendance and where the funds are needed and why. The LL schools are showing more interest and participation and youth attendance including classroom attendance in BOTVIN hence needing additional funding to include all of the referred.

Most of the Middle Schools have resulted in being Level One Certified with the BOTVIN Program. Jeremias comments on positive BOTVIN programs focusing on preventative measures and the ability to, deter by education, potential use and subsequent consequences. Noelle continues by stating it is prevention by way of early intervention regarding substance abuse. It is not intended for addicted youth.

Camille asks a question about referral process.

Noelle states that the referrals come from Probation as well as schools. The probation is on an individual referral basis whereas the schools such as School of Dreams Academy, Los Lunas, Tome, Desert View ... are referring by classroom and providing the supporting resources by way of classroom forums, staff, and after school programs. Los Lunas schools have provided additional resources by way of Teachers and Resource Officers to help teach and support the BOTVIN staff.

The BOTVIN program has teachers and counselors numbering approximately 5 to 6 individuals, trained to get the programs started and run effectively.

Camille thanks Noelle for that information/explanation.

Jeremias states what is being asked for and voted on in funding. \$16,500.00 with 40% Valencia County(VC) Match \$6,600.00 equaling a total of \$23,100.00. He also explains the VC match includes time, building space and Administrative Oversight. Jeremias opens it up for questions and there are none.
