III. JJAC and Coordinator Meeting Updates

- a. In our FY 21-24 grant application we requested a total of \$670,140.66
- **b.** Proposed and recommended funding from CYFD totals \$328,522
- **c.** RAC SODA site was dropped and total days were reduced from 250 to 160 for 3 school sites. The Drop off site is at 250 days and all three will see an increase in the fee from \$250 to \$275. The difference between what we requested and what is recommended is \$143,000
- d. Ruben was informed that we cannot apply for a new program, but could potentially receive funding for something similar to a learning lab under the RAC program. Noelle already has most of the requirements fulfilled and plans to serve all schools in Valencia County. We can apply in July and if approved, could see this running in August.
- **e.** Discussed potential resolutions for transportation issues. Some counties are able to obtain gas cards through fundraising. JJB cannot fundraise, but maybe we can partner with other community organizations to try to help with transportation of youth and families. JPO may be able to get bus vouchers for youth who are system involved.
- **f.** Father Mundy-discussed See It program that addresses human trafficking. Is evidence based out of south California. Additional information can be found at www.roadblocknm.com

a. All present introduced themselves

 - g. Asked about delinquent property tax. Governor stated she isn't going to go after people who cannot afford to pay their taxes.
