#### VII. Introductions and Welcome

b. Father Mundy welcomed all members and guests

c. All meeting attendees introduced themselves

#### VIII. RAC

- a. Restorative Justice contract is pending. Hopefully will be signed within the next 1-2 weeks.
- b. Rustin stated it is on the Cabinet Secretary's desk in Santa Fe waiting for a signature.
- c. A week ago Los Lunas Schools advised that the MOU is in the last step of being approved. All pending MOUs will be approved together and hopefully that will be in December.
- d. The first evening and weekend drop-in was used on Sunday and Elaine did a great job.
- e. Sydney has about 20 cases at SODA
- f. Victoria is handling cases at Belen High, Belen Middle, and Dennis Chavez Elementary schools, as well as home school and suspended kids and has almost 20 cases.
- g. RAC is receiving law enforcement referrals. Yesterday Belen High School had 6 referrals.

## X. Family and Community Wellness Subcommittee

Noelle provided information:

- a. The subcommittee met in October
- b. This month's meeting has been cancelled
- c. In October discussed the RAC food drive and Mission Graduate
- d. Linda gave an OSAP update on her strategic plan that is pending and how she will be able to better support the committee
- e. Diana created a youth flyer that will be submitted to the youth summit to gather their input on media sources they utilize and best ways to reach other youth
- f. Discussed how delinquent behavior and offenses can affect future employment
- g. Looking at a focus group January 3, 2020 during Christmas break so that the meeting can be held during the day for approximately 3 hours
- h. OSAP will be providing food

### XII. Legislative Subcommittee

- a. Tom is trying to meet with the Governor to get needs heard
- b. There are 600 abandoned buildings in Valencia County and it costs money to take them down
- c. Belen Police Chief Rodriguez asked if this subcommittee can address vaping among youth
- d. Commissioner Hyder stated 1 puff from an e-cig is equal to 1 pack, or 20 cigarettes which is not producing higher death rates
- e. Tom is currently the only subcommittee member. Bart stated he will join. Noelle suggested monthly meetings to gain momentum and more involvement
- f. How can VC JJB address vaping and tobacco possession and use in the youth?
- g. Marijuana is expected to be legalized in this 30 day session
- h. How do we get help for those who become regular Marijuana users?
- i. By decriminalizing Marijuana, we are telling kids that it is okay to use

#### XIII. Coordinator Update

- b. We are still being asked to host the meeting either in March or April of 2020
- c. We will not know anything about our grant application until January

  - 6. Kids created a brochure in both English and Spanish
  - 7. Program is being looked at as a model. Have been invited to Florida in June.
