**a)Re-Certification Canvass for the recount 2000 General Election Results**

Valencia County Clerk Kandy Cordova stated that she would provide the recount for the Absentee and Early Voting on the two races in contention and then the final tally. She stated that on the recount for the Absentee Voting for Kandy Cordova, 670, David Vickers, 631, Legislative position in Distrct 7. On the recount for the Absentee Voting for Gary Daves, 195, and Jeffrey Goen, 195, Commission position in District 5. On the recount for the Early Voting for Kandy Cordova, 1006, David Vickers, 1203. On the Early Voting for Gary Daves, 277, Jeffrey Goen, 385. The totals, were, District 7, Legislative race, Kandy Cordova, 5,285, David Vickers, 5,248; District 5, Commission race, Gary Daves, 1,989, Jeffrey Goen, 1,904. Mrs. Cordova then asked Commissioners to approve the recount canvass. Commissioner Giron inquired if any problems had surfaced in the process of the election which could compare to the difficulties being experienced in other States. Mrs. Cordova stated that she was immensely proud of the superior quality of technical expertise in the State of New Mexico. Commissioner Giron made a motion to approve the recount canvass. The motion was seconded by Commissioner Pando and carried.
