Chairman Aurelio H. Padilla called the Meeting to order at 10:00 A.M.

Chairman Padilla asked Tina Gallegos, County Clerk to lead the Pledge of Allegiance.

Mr. Fernandez went through each department line item by line item for the Commission to know where we are at with each department. Commissioners discussed the revenues vs. expenditures while still being real cautious at having the employees back on 40 hours. Mr. Fernandez said there

are 49 positions on 32 hours and if you are looking at bringing the employees back to 40 hours starting yesterday it would be seventeen (17) pay periods. The total amount that would be required for the remainder of the fiscal year would be \$174,426.84. Mr. Fernandez said how that would affect the cash balance, what we have done is add the \$174,426.84 into the expenditures and the anticipated cash balance has dropped down to \$1,309,000.00. Also, Mr. Fernandez said the 3/12 requirement changes when you add to your expenditures. Mr. Fernandez said by placing the employees on 40 hours as of yesterday we would not meet our 3/12 requirement. Commissioner Aguilar said she is more interested in the thirteen (13) pay periods because this would be more realistic. Mr. Fernandez said he has a summary of that projection starting December 23, 2002 for the 49 employees back on 40 hours. This would meet our 3/12 requirement. Commissioner Aguilar said by having another workshop possibly in December we would be closer to the projected revenues and expenditures. Commissioner Daves said he would have administration look closely at the revenue from the Adult Detention Center and this still remains a worry to him. Mr. Fernandez said the first meeting in December we will know the tax revenue from the Treasurer's Office and see where we are. Commission discussed the meeting dates so the paperwork can be approved by DFA so we will move our meeting date to the second week in December. Mr. Fernandez said we do need to be cautious and not bring the employees back too soon because this would be detrimental to the budget as a whole.
