Report on County Assessor's FY 04-05 Accomplishments, Upcoming Initiatives – Beverly Gonzales

Ms. Gonzales gave a brief overview of the accomplishments and upcoming initiatives in the Assessor's Office. Ms. Gonzales discussed general information of how many deeds are processed daily, correspondence, mobile home tax releases, livestock field and data entry, commercial and personal property process, getting online with MVD to handle the manufactured home's, appraisal process, central assessment property, daily recorded plats with splits with regard to subdivisions in the County, yearly sales ratio analysis and not to mention the daily public services that are done and deadlines to meet. The notice of valuations are scheduled to go out May 1, 2005, we were granted an extension from Taxation and Revenue. Ms. Gonzales stated the County does not have a full time mapper and due to being short staffed they are 2 year's behind in accomplishing the mandate that was set for June 2004. Ms. Gonzales requested hiring help to accomplish the goals set to gather the data that is so needed for Valencia County and asked the Commission to take a tour of her department to see all the steps in gathering and generating the value for the county's tax base. Report on County Treasurer's FY 04-05 Accomplishments, Upcoming Initiatives – Diana Martinez-Coplen

Ms. Coplen gave a brief overview of the accomplishments and upcoming initiatives in the Treasurer's Office. Ms. Coplen discussed general information of the daily revenue that passes through the office in a single fiscal year,19 separate bank accounts utilized by the County, average of 100 incoming calls, yearly collection, mailing out of yearly tax bills and the daily public services that are done. Ms. Coplen said they have acquired new equipment, implemented a manufactured home process, worked closely with the Delinquent Property Tax in red tagging properties, and bringing in new un-assessed homes for the County. We have purchased new receipt printers to allow a more cost effective process of handling the payment process. Ms. Coplen said first and foremost she would like to see the employees receive a pay increase and to consider this for the new fiscal budget. Ms. Coplen discussed her equipment needs to better manage her office with an emphasis on allowing the property tax information to be viewed on the website. Tape (1) 900 **Exhibit B**

Board of Commissioners convene as Indigent Board

Indigent Report/Appeals - Barbara Baker

Ms. Baker presented the indigent claims from March 4, 2005 to March 30, 2005. The total amount of claims submitted was \$239,737.05 and Ms. Baker requested the Commission to approve \$28,913.82. There were 64 claims submitted and 20 applicant denials. Commissioner Kirkham moved for approval. Seconded by Commissioner Trujillo. Motion carried unanimously. **Exhibit C**

Ms. Baker presented three appeals, one is for an inmate and Mr. Trujillo has requested approval of that appeal for Jimmy Coffman. This appeal was over the 90-day limit. Commissioner Stublefield moved for approval. Seconded by Commissioner Kirkham. Motion carried unanimously. The second appeal is for Jane Menear and this appeal was denied due to income and illness. Commissioner Stublefield moved for approval. Seconded by Commissioner Trujillo. Motion carried unanimously. The third appeal is for Barbara Williams. She was denied but does have insurance coverage. The co-pays for the three procedures she had done are extremely high and Ms. Williams qualifies in every other way. Commissioner Stublefield moved for approval. Seconded by Commissioner Trujillo. Reconvene as Board of County Commissioner

Approval of contract between Tierra Bonita/Belen High School - Cyndi Sluder

Ms. Sluder presented a contract between Tierra Bonita and Belen High School, Math Department. Through their geometry program they have contests that they perform once a year and are in need of funding. Ms. Sluder said at the site of Otero Road and La Entrada, they can pick up trash and paint graffiti. The number of youth participating will be 30 and 2 adult's supervision. The sum of \$500.00 has been agreed upon by Larry Sanchez, the adult leader of the group who will assume responsibility and liability for the above group. Commissioner Stublefield moved for approval. Approval Amended fiscal year 2002-2003 Audit Engagement Letter – Michael Steininger

Mr. Steininger stated this is an amendment to the engagement letter for the audit of the fiscal year that ended June 30, 2003. There were two FEMA grants that were awarded to two fire departments that were not disclosed to the auditors during the time of the original audit of Valencia's financial statement. We estimate this cost to be between \$5,000 and \$6,000 and will be paid out of the fire department funds. Mr. Steininger said these two fire departments have been notified and are complying with this situation. The fire departments are Tome Adelino and Valencia El Cerro Fire Department. Discussion ensued. Commissioner Stublefield moved for approval. Seconded by Commissioner Trujillo. Motion carried unanimously. Tape (2) 900 Exhibit P

Approval of Payroll & Warrants - Michael Steininger

Commissioner Gentry made a motion to accept the settlement in the Burris v. Yates case with the requirement that the road exchange meets the minimum road criteria which will be placed in that request. Seconded by Commissioner Stublefield. Motion carried unanimously.
