Recognition of Volunteers for County "Great American Clean-Up" – Cyndi Sluder

Ms. Sluder recognized four volunteers La Associacion de la Comunidad de San Clemente, Highland Meadows Fire Department, Thirteenth Judicial District, Judge Pope and the Historic Tome/Adelino Neighborhood Association Ms. Sluder presented plaques for these individuals for all their help in keeping Valencia County clean. Carolyn Romero represented Highland Meadows Fire Department, Josie Maag represented San Clemente Associacion and Cynthia Ferrari represented the Thirteenth Judicial District, Fabio Padilla was not able to attend for the Tome/Adelino Association. Chairman Andersen on behalf of the Commission thanked the above individuals for their participation in the clean-up program.

Review of Solid Waste Ordinance – Commissioner Gentry

Commissioner Gentry reviewed the solid waste ordinance with the Commission. He stated this ordinance has had a committee that worked on it for several years and after that nothing was done to it; it sat on a shelf and didn't go anywhere. Solid Waste and trash pickup had been one of this Commission's priorities and he would like to bring this ordinance before the Commission to be recognized, have legal counsel and staff review it and make sure it is up to policy standards. Commissioner Gentry said then it could be brought back after being updated for commission process. Commissioner Gentry said he would like to thank the committee for putting together such a comprehensive ordinance.

Commissioner Kirkham said solid waste is one of her committees and she was not contacted on any of them. Ms. Sluder said this ordinance was started in 2001 but in the future she will notify Commissioner Kirkham of any meetings.

Mr. Trujillo said it is on a priority list and will be looked into. Commissioner Gentry said it seems like we have a lot of things on a list and he would like to see this item go forward. **EXHIBIT A**

Commission Communication/Questions – County Commissioners

Reports from Boards, Commission & Committees – County Commissioners

Commissioner Pinkston suggested that at the Fire Meeting Workshop on August 8, 2005, she would like a list of the volunteers in each District and their certifications of both fire and EMS. She would like the dates of all of the elections for all fire districts so that they can be coordinated at the same time. Commissioner Pinkston also asked for copies of all departments SOP's and by-laws.

Commissioner Kirkham asked Mr. Trujillo about the contracts for the roadwork money that we received from Santa Fe, have we received this yet, with school starting and bus routes? Mr. Trujillo

said the contracts are not in hand yet but he has heard from DFA that we will receive them the first or second week in August.

Chairman Andersen reported on the State Board of Transportation together with Loretta Tolefson, Council of Governments, Bill Moffat, Finance from the Los Lunas Schools, went to Chama and addressed the issues on Valencia County. Chairman Andersen had a map showing the progress on the building development that is currently being built or planned and there are 3000 homes. This does not include the 5000 acres south of Sun Ranch. It does show the two new schools on the east mesa. The second map that Chairman Andersen addressed showed the traffic patterns that are in effect now, the wider the red line the heavier that road is traveled. Once we get those 3000 homes this will be busy. This has made a big impact on the schools in Valencia County and one issue that was presented was the Manzano Expressway and the crisis this County is in to get that road rebuilt. Ms. Tolefson reported on the mobility study and Mr. Moffat reported on the situation with the busses that are traveled on the Manzano Expressway.

Action Items

Tierra Bonita Youth Group Contract (Salomon Estates) - Cyndi Sluder

Commissioner Kirkham moved for approval. Seconded by Commissioner Pinkston. Motion carried unanimously. **EXHIBIT B**

Resolution 2005- 57, relating to delinquent property tax, waiving the extra penalty on delinquent taxes for the 2005 tax year – Diana Martinez-Coplen

Mr. Steininger presented the above item on behalf of County Treasurer, Ms. Coplen. The Treasurer has recommended that the minimum penalty should be suspended for the current tax year. It has been determined that the minimum penalty is not equitable and that the simple imposition of a one percent penalty as provided for in the statute is more fair to the small taxpayers of the County. Commissioner Trujillo moved for approval. Seconded by Commissioner Kirkham. Motion carried unanimously. **EXHIBIT C**

Lease of Real Property from State Property Control Division, GSD – Mike Trujillo Cottage #3 – Los Lunas Public Health Building

Mr. Trujillo requested approval of the revised lease agreement with State Property Control Division for a 5575 square foot building housing the Los Lunas Health Public Health. The new lease agreement clarifies that the lease is for a term beginning July 1, 2005 and ending July 30, 2015 renewable for three-five year options. Commissioner Gentry moved for approval. Seconded by Commissioner Pinkston. Motion carried unanimously. **EXHIBIT D**

Agreement for Solid Waste/Waste Management Inc. – Mike Trujillo

Mr. Trujillo requested approval of the renewal contract between Waste Management and Valencia County. Marlene Feuer, Waste Management stated that they are willing to continue to accept the waste at a slightly higher rate. The current contract was for a three-year term. This would be considered a professional services agreement that can be contracted up to eight years according to the State Procurement Code. This agreement is one year with two one-year renewals. Chairman Andersen asked with the new rate of 8% being higher than we are currently paying, what is the impact going to be on the budget? Mr. Trujillo said he would have those figures at the next business meeting. Commissioner Trujillo moved for approval. Seconded by Commissioner Kirkham. Motion carried unanimously. **EXHIBIT E**

Adoption of CDBG -"Residential Antidisplacement & Relocation Assistance Plan & Certification" – Ruben Chavez

Re-affirm a decision made by the Planning & Zoning Commission – vacating roads in a plat back in April 2000 – Ruben Chavez

Chairman Andersen said the above item should state affirm a decision not re-affirm because this item never came before the Commission. Commissioner Gentry moved for approval. Seconded by Commissioner Kirkham. Motion carried unanimously. **EXHIBIT H**

Request to Publish – Mike Trujillo

Fire – EMS Ordinance

Mr. Trujillo presented the above ordinances for review to publish. Chairman Andersen asked why two drafts. Commissioner Gentry said the dated draft of August 5, 2005 is the workable ordinance draft. Commissioner Gentry recommended that we authorize publishing of the fire ordinance and stipulate that there are two proposals to be considered at those hearings. Then we can merge them if we need to or we can vote on one or the other but in our publication state that there are two options. Commissioner Pinkston stated she had several discussions on both drafts, the first one staff drew up and the second we had originally requested that it be similar to Sandoval County and there are some things that are not similar and there is a question to that but she would like to see both drafts published. Commissioner Gentry has proposed. Chairman Andersen made a motion to deny the request to publish the Fire EMS ordinance until after the fire chiefs have reviewed both

drafts and we can combine the provisions into one. Seconded by Commissioner Kirkham. Chairman Andersen voted yes. Commissioner Kirkham voted yes. Chairman Andersen stated the motion has died for lack of votes. Commissioner Gentry moved that we put the ordinance up for notice that we are going to publish and mention two options to be considered. Seconded by Commissioner Pinkston. Commissioner Pinkston voted yes. Commissioner Kirkham voted no. Chairman Andersen voted no. Commissioner Gentry voted yes. Commissioner Trujillo voted yes. Motion carried 3-2. **EXHIBITS I & J**
