The meeting was called to order by Chairman Mary Andersen at 9:01 AM.

Chairman Andersen asked Robin Hull to lead the Pledge of Allegiance.

Approval of Agenda

Commissioner Trujillo moved for approval. Seconded by Commissioner Pinkston. Motion carried unanimously.

Approval of Minutes

Commissioner Trujillo moved for approval. Seconded by Commissioner Gentry. Motion carried unanimously.

Public Requests

Amber Stratton was concerned on the proposed fire station on Omar Road. Ms. Stratton listed her concerns to the Commission as she understands this item is not on the agenda. Ms. Stratton said they were not notified and therefore they have a petition against the fire station being built on Omar Road. Commissioner Kirkham said she is part of the committee that looks for the best site location for the new Valencia El Cerro Fire Station. Commissioner Kirkham said the committee came back with a zoning issue and restrictive covenants this is not a good site for its intent and presently looking for a different location.

Discussion (Non-Action) Items

Commuter Rail Project Update - MRCOG - Lawrence Rael

Mr. Rael updated the commission on the ongoing project of the commuter railway system. Mr. Rael explained the route that the railroad will be taking and the different stops that will take place. The operational dates will be Monday thru Friday. If there is a demand for weekends, it will be publicly advertised. There will be shuttles at the stop at Rio Bravo to the airport. There is a development for shuttles at each stop along the route. We will be looking at groundbreaking in the next two or three weeks for the Los Lunas stations. The hours of operation and cost is being discussed extensively and will be finalized by the end of October. There has been a lot of data information that has been used to implement this project. Commissioners thanked Mr. Rael and his staff for all of the hard work that is being done on this project.

Commission Communication/Questions – County Commissioners Reports from Boards, Commissions & Committees – County Commissioners

Commissioner Pinkston reported on her town hall meeting. They covered issues concerning Meadow Lake with regard to roads. There was discussion on organizing a Homeowner's Association. Commissioner Pinkston thanked the road department for the clean-up on Mesa Estates.

Commissioner Kirkham reported on a Juvenile Detention meeting that she and Commissioner Andersen attended. At the meeting representatives from Sandoval, Bernalillo County and Valencia County got information on what a juvenile detention center does and how it operates. Commissioner Kirkham said if we do close this facility and stop providing this service, it could cost Valencia County and Commissioner Kirkham asked if staff could look into this as the Commission has had discussion on the closure of this facility. Chairman Andersen asked for staff to look into a workshop with the judges to discuss this organization and its operation.

Commissioner Gentry reported on a meeting in Belen with regard to the railroad system. There were officials with the railroad and the highway department along with our own staff and since that meeting there has been question on updating the public on what is happening with this project. Mr. Trujillo said he will look into the advertisement process.

Action Items:

a. Resolution 2005-66 "Accepting The Comprehensive Plan of Valencia County and approving The Plan For Public Distribution" – Joe Quintana (SEE EXHIBIT A)

Mr. Quintana said this is the third and final presentation of the comprehensive plan and now will ask for the approval and acceptance of the resolution. We have been successful with the steering committee giving recommendations and all the factual information that has been assembled and reviewed. Commissioner Gentry complimented Mr. Quintana for bringing to light such a great job on this document because it is very well constructed and complete on the history and culture of this area. Commissioners commended Mr. Quintana for such a thorough document. Commissioner Gentry moved for approval. Seconded by Commissioner Trujillo. Motion carried unanimously.

b. Resolution 2005-67, "Relating to Health Care; authorizing a request for information process" - Robin Hull (SEE EXHIBIT B)

Ms. Hull presented the above resolution to the Commission. Ms. Hull brought forward health care recommendations for Valencia County that would work towards development of a comprehensive health care system that includes all of the necessary components for a strong community and economic development. We need to maximize effective use of health care financing and resources that provide needed health care services to the County. Commissioner Pinkston moved for approval. Seconded by Commissioner Trujillo. Motion carried unanimously.

c. Resolution 2005-68, "Dealing with procurement, adopting a revised procurement policy; meeting requirements of federal, state and County procurement laws & regulations" -Mike Trujillo/Michael Steininger (SEE EXHIBIT C)

Mr. Steininger presented the above resolution for the purpose of the state procurement code and this policy would provide a fair and equitable treatment of all persons involved in public procurement, to maximize the purchasing value of public funds and to provide safeguards for maintaining a procurement system of quality and integrity. Commissioner Kirkham moved for approval. Seconded by Commissioner Gentry. Motion carried unanimously.

d. Adoption of 2005 Tax Rate Certification - Beverly Dominguez-Gonzales (SEE **EXHIBIT D)**

Olinda Reneau, Chief Appraiser, Assessor's Office on behalf of County Assessor, Ms. Gonzales presented to the Commission the adoption of the 2005 tax rates. Commissioner Gentry moved for approval. Seconded by Commissioner Trujillo. Motion carried unanimously.
