Discussion (Non-Action) Items: Public Hearing Item:

County Clerk, Tina Gallegos read the oath to the public that wished to give testimony on tonight's public hearing item.

a. Rule on an appeal for a decision made by the P & Z Commission – Ruben Chavez/Jesus Miramontes (Tabled September 16, 2005) (See Exhibit A)

Mr. Chavez presented to the Commission the above appeal and also spoke on behalf of Blanca Ramos who was present and did not speak English. Her husband, Jesus Miramontes was not able to attend. Mr. Chavez said this request is to rule on an appeal for a decision made by the Planning & Zoning Commission. On June 15, 2005 the P & Z Commission heard a request for a variance by Jesus Miramontes. The size of the mobile home is 12 x 65 or 780 square ft. The county ordinance calls for 840 sq. ft. Upon being denied, the applicant believed that having engineered a foundation for an additional 192', further consideration may be given. Mr. Miramontes is seeking leniency from the Commission, as having applied for an appeal. Planning & Zoning Commission denied the request with a 4-0 vote. Commissioners discussed the procedures per policy with regard to the county ordinance that is already in place. Mr. Chavez said this variance is a hardship case and apparently these older mobile homes are not manufactured to HUD standards. Ms. Ramos asked the Commission to consider this request.
