1. The meeting was called to order by Chairman Paul Trujillo at 9:01 AM.

#### 2. Chairman Trujillo asked Perry Randall to lead the Pledge of Allegiance.

#### 3. Approval of Agenda

Mr. Trujillo said Item 6b, Discussion on County Checking Accounts, Diana Martinez-Coplen, cannot be present today as she had a death in her family. Also 7a, we are not quite complete with all of the road cost estimates. Mr. Trujillo announced the in house Attorney, Ms. Wimberly was hired and will start on Monday, March 6, 2006. Commissioner Andersen moved approval of the agenda and to delete the above items as stated by Mr. Trujillo. Seconded by Commissioner Pinkston. Motion carried unanimously.

#### 4. Approval of Minutes

February 8, 2006 - Public Hearing Meeting

February 17, 2006 - Business Meeting

Commissioner Andersen said on the Business Meeting of February 17, 2006, on the paragraph 6 a., the Presentation on the proposed Sausalito Fire Station, there is a couple of sentences that need to be rewritten. It needs to read that Mr. Trujillo will contact the State Fire Marshals Office and start the process and take out the words and put in a substation there. Commissioner Andersen moved for approval on both meetings with the above change for February 17, 2006. Seconded by Commissioner Pinkston. Motion carried unanimously.

#### 5. Public Requests

Judy Babcock, Vice-Chair of the Animal Control Advisory Board asked the Commission to consider a change in the process that is being done at the shelter which requires a deposit for sterilization for an animal that is adopted. We currently have a \$10.00 adoption fee and a \$25.00 deposit that is returned when an animal is adopted, once they show proof that an animal has been sterilized. We are proposing a contract with PET ER that adoption fees be paid but a pre-paid sterilization fee would be taken at the time the animal is adopted.

Dr. Park, Veterinarian, spoke on behalf of PET ER said it is comprised of vets in the county that came together to form an emergency care service for animals that need medical treatment. We saw a need for emergency services and the main way to control the number of animals that we take in is to control the pet population.

Mark Rosenblum said he has been involved with Ms. Babcock in animal rescue in the efforts to spay, neuter or lower prices for several years. There is no place that a legitimate adoption can occur in Bernalillo or Valencia County that would cost less that what is being discussed. It is anywhere from \$100.00 on up.

Commission and staff discussed the fees and procedures. No action taken.

## a. Presentation by Highland Meadows residents on Convenience Center – Carolyn Romero (See Exhibit A)

Roger Lawrence, Highland Meadows on behalf of Carolyn Romero said thank you for giving him an opportunity to speak at today's meeting. Mr. Lawrence said he is here to give his appreciation and support for Highland Meadows/Tierra Bonita Convenience Center pilot project and the clean-up day on February 18, 2006 which was a huge success. Mr. Lawrence said plans for the clean up began in the spring of 2005, as Carolyn Romero and Cyndi Sluder worked well together on ways to offer Highland Meadows residents help in cleaning up the community. Highland Meadows, up until now, has had no services, so they hope to build on this new beginning. The construction of a Community Center is eagerly anticipated. Mr. Lawrence finished reading a brief letter on highlights of the clean-up day.

# b. Consideration of NM LINx, MOU Agreement (tabled February 17, 2006) – Cyndi Wimberly (See Exhibit B)

Ms. Wimberly presented the above item. This is a multi jurisdiction agreement with the Naval Criminal Investigative Service which is the lead agency, this is a computer data base where every participant agrees to put confidential information on this data base. It will require Valencia County to have a dedicated server and policy and procedures by the Sheriff's Department as to who can use this. Sheriff Perea said this will be a valuable resource to the County, this is a tool for investigating crime in the County. There will be no cost to the County. Commissioner Kirkham moved for approval. Seconded by Commissioner Pinkston. Motion carried unanimously.

# e. Request to Publish 2006- An Ordinance Relating to Administration, Ordaining a Personnel Policy; Setting forth Personnel Rules and Regulations Establishing Consistent, Basic Policies and Practices Concerning Relations Between the County and its Employees, Declaring An Emergency – Mike Trujillo (See Exhibit H)

Mr. Trujillo said the personnel ordinance was adopted in 1993. We considered the most update policy the state has which is Curry County and we are recommending a simple adoption with an emergency clause. Mr. Trujillo suggested a workshop on March 17, 2006 to review this proposed policy and then adopt the new rules and regulations. Commissioner Kirkham asked who worked on the policy, was it a task force of employees? Mr. Trujillo said, Michael Oliver, Andrew di Camillo, Dan Trujillo and Jacquelyn Chavira. Commissioner Andersen moved for approval to publish. Seconded by Commissioner Pinkston. Motion carried.
