- 1. The meeting was called to order by Chairman Pedro Rael at 3:30 P.M.
- Chairman Rael led Pledge of Allegiance.

#### Approval of Agenda

Commissioner Pinkston moved for approval. Seconded by Commissioner Kirkham. Motion carried unanimously.

#### Approval of Minutes – December 12, 2007

Commissioner Pinkston moved for approval. Seconded by Commissioner Kirkham. Motion carried unanimously.

#### Public Requests – At the Discretion of the Chair

(For Information Only - limited to two minutes per person on subjects not on this published agenda.)

Torres G. Leyba gave his opinion of the two minute rule and read a prepared speech on the freedom of speech to the board.

Rosemary Lebrecht a resident and one of the Director's of the Meadow Lake Residence Association shared her concerns of a disturbing situation. Ms. Lebrecht said on December 23, 2007 she had received a phone call from a resident of Meadow Lake that a yearling horse was found tortured and dragged along Fence Line Road. She called channel 7 news station that came and filmed the scene and was broadcasted on the channel 7 news. There was a response from the New Mexico Animal Protected Services and they are now in charge of this matter and a reward has been placed for the person or persons responsible. Ms. Lebrecht said that she had called the sheriff and is curious to know if an investigation has been done as she was told it would be.

Commissioner Pinkston responded to Ms. Lebrecht's comment and said that she had spoke with County Attorney, Cynthia Wimberly, who said that it was her understanding that the yearling was picked up on Friday December 28, 2007 from the Road Department and that the animal was inspected and no evidence of branding was noticed. She said the animal was badly decomposed and was hard to determine any evidence, and advised that if this situation happened again to contact the Road Department when unable to contact the Live Stock Board.

Bob Gostishua Director from Meadow Lake Residence Association had concerns with the lighting at the community center and said it has been hit by taggers. He requested lighting for the center. Commissioner Pinkston said she believes there might be funds left over from building the playground, which is part of the community center and with the left over funds, lighting will be added.

Commissioner Pinkston voted for Commissioner Ron Gentry. Commissioner Gentry voted for Ron Gentry. Commissioner Pedro Rael retained the Chair by a 3-2 vote.

Nominations opened for Vice-Chair of the Commission. Chairman Rael nominated Commissioner Georgia Otero-Kirkham. Seconded by Commissioner Medina. Commissioner Pinkston nominated Commissioner Ron Gentry. Seconded by Commissioner Gentry.

Chairman Reel called for a roll call vote. Commissioner Pinkston voted for Commissioner Ron Gentry. Commissioner Otero-Kirkham voted for Georgia Otero-Kirkham. Chairman Rael voted for Commissioner Georgia Otero-Kirkham. Commissioner Gentry voted for Ron Gentry. Commissioner Medina voted for Commissioner Georgia Otero-Kirkham. Commissioner Georgia Otero-Kirkham retained her seat as Vice-Chair by a 3-2 vote.

b) Resolution 2008-01, Adoption of 2006 Open Meetings Act Resolution

Business Meetings and Public Hearing Meetings will stay as they are. On the first and third Wednesday of each month for Business Meetings and Public Hearing Meetings to be held on the second Wednesday of each month unless otherwise specified. Commissioner Kirkham made a motion to approve the days of the Commission Meetings. Seconded by Commissioner Medina. Motion carried unanimously.

Commissioner Kirkham made a motion to change the times of the meetings from 3:30 to 5:00 to give constituents a chance to attend. Seconded by Commissioner Gentry. Commissioner Gentry said the reason the time had been from 5pm to 3:30pm was because the meetings would carry on until late into the night. Chair Rael called for the vote. Motion carried 4-1, with Commissioner Ron Gentry voting no. Since the January meetings had already been published the new times will not start until February, by consensus of the commission.

Commissioner Kirkham made a motion to adopt the above resolution for the Open Meetings Act with the changes of the times of the meetings. Commissioner Medina seconded. Motion carried, County Clerk, Sally Peres announced the Resolution 2008-01. See Exhibit A.

Commission discussed the following changes under Administrative Services; to take out information: Technology and the Building Maintenance Office; change Tierra Bonita Program from Public Works and replace it under Special Ad Hock Committee and to eliminate the Trash Communities, Heavy Industrial Committee and the Comprehensive Plan Steering Committee. Commissioner Pinkston moved for approval with the above changes. Seconded by Commissioner Kirkham. Commissioner Medina asked to see the chart after it is revised. Motion carried unanimously. Ms. Baker said this is the only county that has an Indigent Board and requested to keep them for their knowledge even if they only meet once Commissioner Pinkston made a motion to retain the board as is. Seconded by Commissioner Medina. Motion carried unanimously.

Emergency Medical Services Board -

After discussion Chair indicated the changes and additions; Chief Casey Davis Meadow Lake #4, appoint Ruben Chavez Valencia County Representative a member, leave John Cherry Sr. as (retired) Ex Officio and Commissioner Pinkston as Ex-Officio. Commissioner Pinkston made a motion to approve with the changes. Seconded by Commissioner Medina. Motion carried unanimously.
