a) Amend the Zoning Map from C-1 to C-2 to allow for the operation of a retail commercial center for the following; portable storage buildings, landscaping/building materials. RV storage facility, computer service shop & weekend flea market; T7N, R4E, Section 29, NMPM; Meadow Lake Subdivision, Unit 3, Tracts 8,9,10 &11; consisting of 1.7 acres; Zoned C-1; also known as 741 Meadow lake Rd, Los Lunas, Valencia County, NM – James Aranda/ JKL Enterprises, Inc., David Seville-Agent (See Exhibit A)

County Clerk Sally Perea administered the oath to those wishing to speak at tonight's meeting.

James Aranda said this request met the review criteria for quasi-judicial zone change. The only concern is the proposed access would cause a five way intersection and the access is in a catty-corner into the business. He said this would be addressed at the time of site design review. This request was heard at the August 27, 2008, Planning and Zoning Meeting and the P & Z Commission approved the request 5-0. Chairman Rael asked Mr. Aranda to explain the access problem. Mr. Aranda explained visually with a map of the proposed area and suggested the access be further off Canada

Mr. David Seville said this is an expansion of an existing business and has served the community of Meadow Lake for twenty-five years. One percent of residents of Meadow Lake have signed the petition in support of expansion. As far as the access is concern, we can make that adjustment.

Commissioner Kirkham asked if public utilities will be available at the weekend flea market. Mr. Seville said a handicap and two regular out door portable toilets have been purchased for the flea market. Also the building has public facilities including water.

Commissioner Pinkston said this is a great business for Meadow Lake and is in favor of it.

Commissioner Gentry introduced a member of the audience Don Holiday.
