- 1. The meeting was called to order by Chairman Pedro Rael at 5:00 P.M.
- 2. Chairman Rael led the Pledge of Allegiance.
- 3. Approval of Agenda

County Manager Eric Zamora requested an emergency item be added to Executive Session, regarding Torrez vs. County.

Commissioner Kirkham moved for approval with the addition of Torrez vs. County as an emergency basis. Seconded by Commissioner Pinkston. Motion carried unanimously.

4. Approval of Minutes - September 10, 2008

Commissioner Medina moved for approval. Seconded by Commissioner Pinkston. Motion carried unanimously. September 17, 2008

Commissioner Kirkham moved for approval. Seconded by Commissioner Pinkston. Motion carried unanimously.

5. Public Requests – At the discretion of the Chair (For Information Only- limited to two minutes per person on subjects not on this published agenda)

Jon Clemons a resident of Las Maravillas shared concerns of bullet holes on traffic signs located at Pasitos Subdivision and Habitat Way road.

Commissioner Kirkham asked Mr. Zamora on the status of the new stop signs. County Manager Eric Zamora said road design is currently under contract through the state engineer's office and are looking to be complete in mid November.

Commissioner Kirkham said unfortunately we cannot put new stop signs until we have the design criteria. She requested a list of signs having bullet holes.

Bob Gostisha thanked Commissioner Pinkston for beginning the process of installing security lights and cameras at the Meadow Lake Community Center.

Jim Lane a resident of Meadow Lake commented that several stop signs were replaced and attested the frequency of new bullet holes has diminished.

Sheriff Rene Rivera addressed a conflict of interest with the County Manager and requested direction from the Commission to help resolve the issue. County Manager Eric Zamora addressed comments made by Sheriff Rivera. Chairman Rael requested the matter be on the next agenda.

Sam Aragon commented on property taxes that need to be collected.

Belen from the Belen Community Center to the Belen Administration Building. Ms. Perea said a court order will be needed and will meet with the County Attorney to begin the process. They will begin to inform the public as soon as possible.

County Manager Eric Zamora is an alternate on Regional Transportation Planning Committee. He has been asked to send a request of proposal evaluation claim. The Evaluation Committee will be revealing proposals for interchange study. He is expecting proposals by Friday, October 3, 2008. Evaluations will take effect Tuesday, October 7, 2008.

Ruben Chavez is promoting a "Pit Bull Rumble" on Saturday, October 4, 2008 from 10:00 A.M - 4:00 P.M at the Sports Complex/BMX Park to raise funds for the Animal Shelter. Mr. Chavez said Charles Benns owner of the Pit Bull Monster Truck will provide an exhibition and donate proceeds to the shelter. Mr. Chavez recognized Janelle Chavez for rescuing "Cupcake" the pit bull puppy whose ears were mangled and he was left at the shelter. Judy Babcock was recognized for finding fourteen sponsors to donate a thousand dollars each to help offset the shelter's cost.

Chairman Rael read the proclamation and awarded the proclamation to Lisa Berry and Mr. Charles Benns.

County Attorney Adren Nance said this begins the process to vacate roads to comply with the "Order Enforcing Settlement Agreement in Burris vs. Yates and Cibola Energy Corporation and Elizabeth Burris". Mr. Nance requested that the Board appoint three road viewers to report their findings and recommendations. Commissioner Gentry recommended utilizing the previous three freeholders and made a motion to accept John Fredrick, Frank Barr and Jon Clemons to be the freeholders for the purposes discussed. Seconded by Commissioner Pinkston. Motion carried unanimously. (See Exhibit H)

Commissioner Pinkston questioned the renovation plans for Meadow Lake Center. Mr. Campos said a leach field is needed, security lighting and replacing the air conditioning units. He explained the state recognizes the center as a Senior Center and the operational dollars and capital layout monies are to assure the seniors are been taken care of.

Commissioner Pinkston said she also has been working on Meadow Lake Community Center and has funding available from the Legislators for the air conditioning units and security lighting.

Chairman Rael shared his concerns of duplicating the efforts and losing either of the funding. Commissioner Gentry said he had written the original bill for the center known as "Community and Senior Center".

Commissioner Kirkham asked if other Senior Centers can use the money. Mr. Campos said the money is for specific centers, as requested and the money can be used throughout a four year period.

Commissioner Kirkham moved for approval. Seconded by Commissioner Pinkston. Motion carried unanimously. (See Exhibit I)

County Manager Eric Zamora gave a brief summary and said twelve applications were submitted. A review committee existed of staff members and members of the commission to interview the four finalists. Mr. Zamora recommends hiring Kenneth Griego. Commissioner Medina moved to hire Kenneth Griego. Seconded by Commissioner Gentry. Motion carried unanimously.

10. County Manager's Report

Eric Zamora reported the General Election's Early Voting begins October 18, 2008 through November 1, 2008 at Valencia County Courthouse in the Commissioner's Board Room.

He also reported that Ms. Abril and he had compiled a summary of first quarter gross receipt revenues for the fiscal year. He said our budget receipt revenues are significantly down and expected to continue. Discussions were made with department directors to scrutinize their budgets for the remaining of the fiscal year and to avoid unneeded expenditures. Chairman Rael requested compiled figures and to plan meeting before the end of the month or in November.

Commission Kirkham suggested creating a committee to review cut backs of supplies. Commissioner Medina suggested looking into county vehicles being taken home.

11. The next Public Hearing Meeting of the Valencia County Board of County Commission will be held on October 8, 2008 at 5:00 PM in the County Commission Room at the Valencia County Courthouse.
