

## VALENCIA BOUNTY BOARD OF COUNTY COMMISSIONERS RESOLUTION № 2017-\_\_/\_\_\_\_

## ADOPTING A SOLID WASTE FEE RELATED TO TRANSPORTING OF SOLID WASTE TO CONEJO CONVENIENCE CENTER

WHEREAS, the Board of County Commissioners met in a regularly scheduled meeting on Wednesday, February 1, 2017 in the Valencia County Courthouse, Commissioner's Room, 444 Luna Avenue, Los Lunas, NM 87031; and,

**WHEREAS**, NMSA Sections 4-56-1 through 4-56-3 authorizes the county to establish and maintain, manage and supervise a system of storage, collection and disposal of all refuse; and,

**WHEREAS**, the Valencia County Ordinance Number 2010-01, the Solid Waste Management Ordinance, adopted May 19<sup>th</sup>, 2010 and codified as Valencia Code of Ordinances section 50 provides for residential and commercial solid waste collection; and,

WHEREAS, Section 50.07 (J) provides that "[t]ransportation of solid waste shall be accomplished through the use of a vehicle with a tightly secured cover. Such vehicles shall be operated to prevent offensive odors escaping therefrom, and solid waste from being blown, dropped or spilled. Persons transporting solid waste without a tightly secure cover will be subject to additional fees as established by resolution;" and,

**NOW THEREFORE, BE IT RESOLVED**, that the Board of County Commissioners that hereby adopts the following fee schedule for all vehicles transporting Solid Waste without a tightly secured cover to the Conejo Transfer Station. *See*, Exhibit A (attached).

**BE IT FURTHER RESOLVED**, persons transporting unsecured waste shall be required to pay the fee prior to disposing of the solid at the Conejo Transfer Station.

**BE IT FURTHER RESOLVED**, after receipt of the fee the County Transfer Station Attendant will provide the payee a suitable cover to secure future solid waste loads if the covers are available.

**BE IT FURTHER RESOLVED**, that Resolution 2009-30 and all other resolutions inconsistent with this resolution are hereby repealed.
