Resolution Number 2021 – 31

ESTABLISHING THE POLLING PLACES FOR THE 2021 REGULAR ELECTION; REPEALING & REPLACING RESOLUTION 2019-31

WHEREAS, on 5th day of June, 2019, pursuant to the New Mexico Statutes Annotated 1978, Section 1-3-2, in Resolution 2019-32, the Board of County Commissioners designated the location of election day polling places in the county for the conduct of any statewide election conducted in calendar years 2020 and 2021; *and*

WHEREAS, the Board of County Commissioners finds that each polling place designated in this resolution complies with the provisions of NMSA 1978, Section 1-3-7, titled Polling Places; *and*

WHEREAS, the Board of County Commissioners finds that those precincts that are consolidated to create Voting Convenience Centers meet the requirements of NMSA 1978, Section 1-3-4, will be available to voters of any precinct in the county to cast a vote at the Voting Convenience Center, will make voting more convenient and accessible to voters of the consolidated precinct, will not result in delays for voters in the voting process, and are centrally located within the consolidated precinct; *and*

WHEREAS, the Board of County Commissioners finds that that each polling place provides individuals with physical mobility limitations unobstructed access to at least one voting machine; *and*

NOW, THEREFORE, BE IT RESOLVED that the Board of County Commissioners designates the polling locations for the 2021 Regular Local Election as follows:

NOW, BE IT FURTHER RESOLVED THAT, resolution 2019-31 is repealed and replaced with the adoption of this resolution.


