**WHEREAS**, on January 3, 2024 this Board approved Resolution 2024-08 appointing the board and committee members of the Valencia County Commission; and,


**WHEREAS**, the Commission has determined that Resolution 2024-08 requires amendment to update a current appointment on a board.






