



RESOLUTION № 2024- 61

AN ANNUAL AUTHORIZATION FOR THE VALENCIA COUNTY SHERIFF'S OFFICE TO PARTICIPATE IN THE FEDERAL LAW ENFORCEMENT SUPPORT PROGRAM AND CERTIFYING ITS RECEIPT OF THE COMPREHENSIVE LIST OF CONTROLLED PROPERTY THAT MAY BE REQUESTED THROUGH THE PROGRAM

WHEREAS, the Valencia County Board of Commissioners met upon notice of a Business Meeting, duly published, at the Valencia County Administration Building, 444 Luna Avenue, Los Lunas, New Mexico 87031 on Wednesday, September 18, 2024, at 5:00 PM as required by law; and,

WHEREAS, NMSA 1978, Section 4-37-1 (1995) provides that Counties have the power to, "provide for the safety, preserve the health, promote the prosperity and improve the morals, order, comfort and convenience of any county or its inhabitants"; and,

WHEREAS, NMSA, 1978, Section 4-38-18 (1976) provides that a Board of County Commissioner has the duty and authority "[t]o represent the county and have the care of the county property and the management of the interest of the county in all cases where no other provision is made by law; and,

WHEREAS, NMSA 1978, Section 4-38-13 (1953) provides that board of county commissioners shall have power at any session to make such orders concerning the property belonging to the county as they may deem expedient; and,

WHEREAS, the Valencia County Sheriff's Office has received property from the Defense Logistics Agency of the US Government as a participating law enforcement agency including but not limited to a Mine-Resistant Ambush Protected (MRAP) vehicle; and,

WHEREAS, the Defense Logistics Agency issue an August 15, 2022 Memorandum for Law Enforcement Support Office (LESO) Program Participating Law Enforcement Agency based on Presidential Executive Order 14074 dated May 25, 2022, setting forth additional requirements for participation in the program.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of the County of Valencia, in accordance with the August 15, 2022 memorandum and acting as the Civilian Governing Body (CGB) of the County of Valencia, does hereby authorize the Valencia County Sheriff's Office participation in the LESO program.

BE IT FURTHER RESOLVED that this Board acknowledges that it has been provided a comprehensive list of controlled property that may be requested by the Sheriff's Office through the LESO program, a copy of which is attached hereto and incorporated into this Resolution by Reference.
