The following items shall be incorporated into the Contract Documents.

All other provisions of the Contract Documents shall remain unchanged. This addendum is hereby made part of the Contract Documents to the same extent as though it were originally included therein. Each bidder shall acknowledge receipt of this addendum on the Bid Proposal Form in the space provided.

QUESTIONS FROM PRE-BID MEETING/SITE VISIT AT VC JUDICIAL COMPLEX ON 10-11-16 AND QUESTIONS SUBMITTED BY EMAIL.

1. Are working hours restricted to 8-5 on weekdays only or can weekends or nights be allowed?

ANSWER: After hours and weekends can be worked but exact times will have to be coordinated

with owner after award of contract.

2. How long has the HVAC control system been a problem?

ANSWER: At least 5 years or more

3. If the actuators for the air dampers are not working do we need to replace them?

ANSWER: Inoperable damper actuators will be addressed on a case-by case basis.

4. Is wireless an option?

ANSWER: Wireless is not an option except for the temperature sensors for Elevator Room#1 and #2 and IT Room.

5. Is T &B required by the contractor?

ANSWER: Yes. See specification section 230593.

6. Smoke damper operation was referred to in the Keyed Notes but not included in the sequence of operations. Can this be clarified?

ANSWER: Smoke dampers to provide alarm when closed.

7. How many relief fans exist?

ANSWER: EF-1 and EF-2 are used for relief. See 'SEQUENCE OF OPERATIONS, SYSTEM OVERVIEW", SHEET M-4.

8. Is a wage rate going to be provided?

ANSWER: Yes. See Appendix F included in this Addendum #1.

9. If the thermostat does not exist in the courtrooms, do you want it added?

ANSWER: Yes. Install thermostat in Courtrooms. Currently there are only monitoring thermostats

in the return duct. One exception is Room 105 'Domestic Violence Hearing room' it has a

standalone thermostat that is to be replaced with a new DDC thermostat.

10. Can old wiring be used?

ANSWER: No. All wiring, with the exception of thermostat to VAV box, is to be removed and replaced with new wiring per the drawings.

11. What level of demolition is expected?

ANSWER: See Section 230501 and also answer to question #10.

12. If it is stand alone?

ANSWER: See Section 230923-2.03 (D).

13. Will it require a server based platform?

ANSWER: See Section 230923-2.03 (D).

14. Will there need to be remote access to the control system?

ANSWER: See 'GENERAL NOTE "F", Sheet M-1, M-2 and M-3.

15. Will remote access be stand alone or on the IT server?

ANSWER: Contractor will replace current Cat. 5 cable with Cat 6 cable from the HVAC DDC equipment room on the third floor and route to IT Server room on the third floor. County will provide internet connection.

- 16. Will there need to be an internet drop and if so will the contractor be responsible for this?ANSWER: See answer to question #15.
- 17. Are the splits included in this bid?

ANSWER: Contractor will add sensor to monitor temperatures in Elevator rooms #1 and #2 and

Main IT Room (first floor). Sensors to Alarm at 80 Deg F initially and be adjustable.

18. Will thermostats be expected to be added to the splits? If so, how many are there?

ANSWER: See answer to question #17.

- 19. Would the County expect thermostats in the elevator equipment room and if so how many?ANSWER: See answer to question #17.
- 20. Is there a preference for BACnet?

ANSWER: BACnet. See Section 230923.

21. What is the model of the McQuay air handler?

ANSWER: GOI/Drawing number-806097010R01-515 was be used to look up units.

Model#RPS090CSA

Serial#FBOU061201157-(The second unit is FBOU061201157)

22. Has the McQuay air handler been LONmark converted?

ANSWER: Yes, RTU-1 and RTU-2 will have to communicate with new BACnet system.

23. Are exhaust fans monitoring and operation required?

ANSWER: EF-1 and EF-2 (VFD), See answer to question #7.

24. Will this project be phased?

ANSWER: Yes. Contractor will go floor by floor. There are no breaks between floors. Contactor may have to go back to a Court room if it is occupied while they are on that floor.

25. Will VFD be replaced?

ANSWER: No. If there is an issue it will be handled during construction.

26. Will staff background checks etc. be required?

ANSWER: No

- 27. Are the two types of systems mentioned in the IFB the only two systems allowed?ANSWER: Any control system in existence for more than 5 years and is 'EQUAL PERFORMANCE' can be bid.
- 28. Sheets M-1, 2, and 3 keynote 14 state "install fire smoke damper and smoke damper monitor per sequence of operation." There isn't a fire smoke damper or monitor listed in the sequence of operation. Could we find out exactly what we are being asked to provide for this note? ANSWER: Smoke Dampers to send out alarm if they close.
- 29. During the site visit we did not look at the server room cooling units and condensers. Key note 12 on sheet M-1 state "install new controller for all server room cooling units and condensers" These units are not listed on the equipment schedule, could we have the model numbers for the units so we can determine what controls will be necessary to operate them please?

ANSWER: See answers to question #17 and #30.

30. The plan M-1 shows RTU-3 and key note 11 indicates that we are to install a new controller for this unit, this unit isn't detailed anywhere else in the plans, would we be able to get some information on what the model of the unit is and the sequence of operation for it?

ANSWER: Delete RTU-3, SCU-1, SCU-2, SAC-1 and SAC-2 they were deleted from original project and were never installed. Ductwork was extended from RTU-1 during original construction.

- 31. Will parking space be provided for the contractor and subcontractors?ANSWER: Yes, in the front and possibly in the back if there is space.
- 32. Will parking be free of charge?

ANSWER: Yes

33. Will there be a staging area?

ANSWER: Yes. Area will be defined after bid.

- 34. Please provide Make, Model Number, and Serial Number for RTU-1, RTU-2, and RTU-3.ANSWER: Refer to answers to questions #20 & #21.
- 35. Sheet M-3 Keyed Note 13 states "Install new controller for packaged Variable Air Handling units on Roof". M-3 Keyed Note 4 states "Disconnect and Remove all controllers from packaged air handling units on roof in preparation for installation of new controller". The existing McQuay Rooftop units RTU-1 and RTU-2 have factory installed controls with factory safeties and control logic. Is the contractor to remove the factory controls and provide all new controls? Or integrate the existing controls into the new system?

ANSWER: Contractor to integrate new BACnet system into RTU-1, RTU-2, EF-1 and EF-2.

36. Similar question for RTU-3. Please clarify what RTU-3 has for existing controls.

ANSWER: See answer to question #30.

37. The plans and specification mention an Electrical (Division 16) contractor. I assume this contractor is a subcontractor to the controls contractor. Is this correct?

ANSWER: Electrical contractor to be sub to controls contractor if required.

38. At the building walk thru, it was stated the <u>all</u> wiring is to be new. The plans indicate thermostat cabling is to be reused. Please clarify what wiring if any can be reused.

ANSWER: Only thermostat to existing VAV box wiring can be reused. All other wiring must be new.

39. The General Notes state "Provide six IP addresses for the building (1 for each rooftop unit, 1 for each floor, and one for external remote access) Please clarify what the intent is. And there are three rooftops and three floors. Does this make seven (7) total IP addresses for the system when you include one IP address for external remote access?

ANSWER: Contractor to provide IP addresses as their system requires. Provide one IP address per floor if required for remote communication.

- 40. Please confirm the New user interface shall be a desktop computer without Server software.ANSWER: See specifications Section 230923-2.03 (D).
- 41. Please confirm the contractor is responsible for providing the Ethernet IP network backbone and internet service with Ethernet firewall?

ANSWER: Contractor to provide Ethernet IP network backbone as required. Internet access will be supplied by County IT. See answer to question #15.

- 42. For how long shall the contractor provide internet service?ANSWER: See answer to question #15.
- 43. Should Payment and Performance bond costs be included in the Base Bid?ANSWER: Yes.

44. Please clarify Keyed Note 14 on drawings in regards to the Fire/Smoke Dampers, status monitor and sequence of operation.

ANSWER: See answer to question # 6.

45. Please clarify the level of demolition for the existing control field devices.

ANSWER: See specifications Section 230501.

46. Please clarity the reuse of any existing wiring, conduit, panels, etc.

ANSWER: See answer to question # 10 in reference to wiring. Contractor shall verify if conduit and panels can be reused on a case by case basis for their proposed DDC system.
