During this time 248 drug tests were given. There were 23 positive tests and 225 negative tests. This is a negative percentage of 91%.

Drug Court had 3 graduates, 2 unsatisfactory terminations and 0 satisfactory terminations during this time.

The educational status of the graduates is as follows:

There were 669 client days in this period. Our total expenditures were \$12,328.77. This includes the value of essential services that were donated. The cost per day for the client and one family member was \$9.21. Traditional detention costs \$125.00 per day. If our clients were in detention rather than Drug Court the total cost to the taxpayers would have been \$83,625.00. The savings from having a client in Drug Court as opposed to detention was \$71,296.23 or \$115.79 per day.
