During this time 251 drug tests were given. There were 10 positive tests and 241 negative tests. This is a negative percentage of 96%.

Drug Court had 0 graduates, 1 unsatisfactory terminations and 0 satisfactory terminations during this time.

There were 673 client days in this period. Our total expenditures were \$12,739.73. This includes the value of essential services that were donated. The cost per day for the client and one family member was \$9.46. Traditional detention costs \$125.00 per day. If our clients were in detention rather than Drug Court the total cost to the taxpayers would have been \$84,125.00. The savings from having a client in Drug Court as opposed to detention was \$71,385.27 or \$115.54 per day.
