- Belen Economic Development, *Steven Tomita* Steve Tomita, Development Services Director for City of Belen, introduced himself and made a presentation of the current economic development initiatives in Belen.
- Retired Senior Volunteer, *Kathleen Pickering* Kathleen Pickering described the AmeriCorps RSVP 2-year Senior Demonstration Grant that the City of Belen was awarded. She discussed the workforce-readiness focus of the
