- Clothing promoting drug paraphernalia
- Any other clothing which the staff deems as inappropriate for visitation in a correctional facility

Visitation Policy

Valencia County Detention Center is dedicated to providing an effective visiting program that encourages inmates to maintain family communication while satisfying the facility's security requirements. In order to accomplish this, we have certain policies/procedures that visitors shall abide by.

Inmates will be in charge of their visitation list. Forms are available in housing units.

A. five people per list, children are not included in the

B. list can only be changed after six months of incarceration

Once list is in file, individuals on list are required to bring identification. Visitors 16 years and older are also required to surrender identification upon signing in for visitation. Visitations forms will be filled out and approval or disapproval will then be granted.

No visitor under the age of 18 will be allowed to visit without first having been properly identified and accompanied by a responsible parent or guardian.
