		and Mrs. Conant own a portion of property off Highway 47 and runs a coffee			
98	distribution business on this site which is a non-conforming use business as well as a raspberry farm which				
99	is allowable in an RR-2 district. Mr. Martinez stated there is an old adobe house on the property which				
100	the Conant's would like to fix up and turn into a small café which would feature some soups, salads,				
101	raspberry products. Mr. Martinez stated this item came before the Planning and Zoning Commission in				
102	November of 2014 and was tabled due to community opposition towards the zone change. Mr. Martinez				
103	stated after meetings between Mr. Conant and Tome Community members, it was decided Mr. Conant				
104	would meet the criteria for a Conditional Use Home Occupation which would allow the café and keep the				
105	land from being re-zoned to a commercial property. Mr. Martinez stated if in the future the business				
106	being allowed should cause more traffic or concerns for the community, the possibility of re-zoning the				
107	property to C-2 could be	considered.

ers 110 about the traffic and asked Mr. Martinez if these members would be satisfied with this application as the

111 traffic issue would still be there.

112 113 Mr. Martinez stated since Mr. Conant has the raspberry farm and there are people who come to pick 114 raspberries, there shouldn't too much of an increase in traffic. 115 116 Chairman Baca asked if this Conditional Use is for the coffee distribution and not for the coffee shop. 117 118 **Mr. Martinez** stated the coffee distribution and the café are incorporated in the request. 119 120 Chairman Baca stated the Agenda states the request is for a wholesale coffee distribution only and does 121 not state anything about the coffee shop. Chairman Baca asked Mr. Martinez if the Commission could act 122 on something that is not declared to the public. 123 124 Mr. Martinez stated he would like the Agenda to reflect that and would like to verify the wording on the 125 public notice letters as well. 126 127 Commissioner McCartney stated if anybody has any concerns or regards to the traffic they have the 128 opportunity to come to these hearings. 129 130 Chairman Baca stated he would like to know what the letters state. 131 132 Mr. Martinez stated the letters do state coffee distribution only and does not declare the café. Mr. 133 Martinez stated this will need to be brought back to the Commission with the correct language on the 134 Agenda and would like Mr. Conant to briefly give the Commission his previous testimony on his plans and 135 ideas for the property. 136 137 **Commissioner Moran** asked if there would be three different business licenses for this property. 138 139 Mr. Martinez stated there is a current business license for the coffee distribution and the raspberry farm 140 does not require one since it is an agricultural use. 141 142 Mr. Conant came before the Commission and gave a brief presentation regarding his desire to rehabilitate 143 the old adobe house on the property and create a small café and retail shop which would include soups, 144 salads, raspberry products from the farm, etc. 145 146 Commissioner Baca asked if there was anybody in favor of the request. 147 148 Mrs. Rhodes stated her name is Jerri and she is one of the community residents who was at the meeting 149 when Mr. Conant applied for the zone change and was concerned should the zone change be approved the 150 community plan they are trying to get passed would be side stepped. Mrs. Rhodes stated she and the Tome 151 Committee were pleased Mr. Conant was willing to work them and would like to see the old adobe house 152 restored and the Conant's succeed in their dream. 153 154 Mr. Greer stated his name is Tom and he is also a member of the Tome Committee and is also in favor of 155 the application. 156 157 Chairman Baca asked if there was anybody in opposition. Chairman Baca stated there is nobody in 158 opposition. 159 160 There was a motion to table the item for the February 24, 2015 Planning & Zoning meeting to reflect the 161 correct language on the application which should read "To allow for small retail/café". 162 163 Approve Action: 164 Commissioner McCartney Moved By: 165 Seconded By: Commissioner Louie 166 Motion Passed: Unanimously 4-0
