- 1) The meeting was called to order by Chairman Holliday at 1:30 P.M.
- 2) Chairman Holliday led the Pledge of Allegiance.

3) Approval of Agenda

Commissioner Otero-Kirkham moved for approval of the agenda. Seconded by Chairman Holliday. Motion carried.

ACTION ITEM(S)

4) Termination of Finance Director Contract.

Chairman Holliday said this item was discussed in length at the last meeting during Executive Session. Commissioner Andersen moved to cancel the Finance Director Contract in accordance with paragraph (5) of the contract. Seconded by Commissioner Otero-Kirkham. Motion carried 4-0. Commissioner Romero was absent.

5) Consideration of Approval for Emergency Prohibition of all Open and Controlled Burning in Valencia County Ordinance 2012-02 – Bruce Swingle / Charles Eaton.

Valencia County Fire Chief Charles Eaton stated this is a request to consider restricting open burning due to the volume of calls they received regarding the drought conditions in Valencia County. We are now in the extreme stage of our weather conditions. The membership and leadership has asked Chief Eaton to come before the commission to ask to place a total ban on all open burning until Valencia County gets some relief in terms of moisture and the weather improves. This would be consistent with what the state adopted a few weeks ago in which burn restrictions were imposed on all state lands. Hopefully this will be a temporary restriction in anticipation that the monsoon season beginning soon. Hopefully this restriction will last no longer than two to three weeks.

Commissioner Gentry said this particular ordinance just goes on and has no clause in it to repeal it, severed it or allow it. This looks like it's going to take a large action whenever we want to cancel this. Maybe counsel can direct us not to get into something that has no end. We need to give the Fire Chief the discretion to raise that and to decide whether it's a burn day or not.

Chairman Holliday said we need to have something that says until we have a considerable measureable amount of rainfall throughout the county then the ban is lifted. With a considerable amount of rainfall Chief Eaton has the authority to make that call. County Attorney Adren Nance said currently the way it's written, it would be rescinded by a resolution by the Board of County Commissioners. That could easily be changed so that it says "the Fire Chief can rescind the ordinance when he determines that conditions are favorable".

Commissioner Andersen moved to pass the ordinance with that change as stated by counsel. Seconded by Chairman Holliday. Motion carried 4-0.

NOTICE OF TERMINATION FINANCE DIRECTOR CONTRACT

WHEREAS, the Board of County Commissioners of Valencia County met in a duly noticed special meeting on July 3, 2012 at the Valencia County Administration 444 Luna Ave., Los Lunas, New Mexico; and,

WHEREAS, NMSA 1978, Section 4-38-19 (1973) provides in pertinent part "[a] board of county commissioners may set the salaries of such employees and deputies as it feels necessary to discharge the functions of the county;" and,

WHEREAS, on May 2, 2012 the Board approved a contract of employment ("contact") with Mr. Larry A. Augsbury to serve as the Valencia County Finance Director; and,

WHEREAS, section 5 of the contract provides in pertinent part that "[t]he Board may terminate this Agreement by delivering to Mr. Augsbury a written notice of the Board's intent to terminate this Agreement, as determined by a minimum of a 3/5 vote of the Board.

NOW THEREFORE, the Board of County Commissioners hereby elects to terminate the contract pursuant to section 5 of the contract and give notice thereof.

NOW THEREFORE, be it ordered that County Manager Bruce Swingle is authorized and directed to take any and all action(s) necessary to effectuate the termination of the contract pursuant to its terms.



VALENCIA COUNTY ORDINANCE NO. 2012-02

AN ORDINANCE DECLARING AN EMERGENCY AND PROHIBITING ALL OPEN AND CONTROLLED BURNING IN VALENCIA COUNTY, NEW MEXICO

WHEREAS, NMSA 1978, Section 3-18-1 (1972) provides that municipalities, and also counties pursuant to NMSA 1978, Section 4-37-1 (1995), have the power to "protect generally the property of its municipality and its inhabitants" and to "preserve peace and order"; and,

WHEREAS, Section 4-37-1 et seq. NMSA 1978 provides that counties may adopt ordinances, not inconsistent with statutory or constitutional limitations placed on counties, to discharge those powers necessary and proper to provide for the safety, preserve the health, promote the prosperity and improve the morals, order, comfort and convenience of the county and its inhabitants; and

WHEREAS, the danger of brush fires, grass fires, forest fires and structure fires is extremely high in the State of New Mexico and especially Valencia County and the surrounding jurisdictions; and,

WHEREAS, current conditions such as relative humidity, weather and fuel content and condition create an extremely high fire hazard in Valencia County; and,

WHEREAS, the probability of ignition of material and fire spread is extremely high in Valencia County; and,

WHEREAS, the Whitewater Baldy fire, the largest wildfire in New Mexico's history ,thus far consuming approximately 300,000 acres, is currently burning in Catron County New Mexico; and,

WHEREAS, the Little Bear Fire, thus far consuming over 225 structures and approximately 45,000 acres, is currently burning in Lincoln County, New Mexico; and,

WHEREAS, on June 12, 2012 the State Forestry Division placed a burn ban on restrictions on certain lands in New Mexico; and,

WHEREAS, due to continued drought conditions and the extreme fire danger in the bosque area of the Middle Rio Grande Conservancy District, as of 8:00 a.m. Friday, June 29, 2012, the bosque in Sandoval, Valencia and Socorro Counties was closed by the District; and,

WHEREAS, an immediate danger to the public health, safety and welfare of Valencia County residents has arisen due to extreme drought and fire conditions within the County; and,

WHEREAS, it is necessary to prohibit all open and controlled burning within the unincorporated areas of Valencia County.

NOW THEREFORE, BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS, THAT:

Section 1. EMERGENCY DECLARATION

The Board of County Commissioners hereby declares that Valencia County is suffering from extremely or serious drought conditions and high fire hazards represent a significant immediately threat to the peace, safety, health and welfare of Valencia County.

Section 2. BURNING PROHIBITION

ALL OUTDOOR BURNING including the following types of burning are hereby prohibited in the unincorporated areas of Valencia County:

- A. Campfires ("Campfire" means a fire set for cooking, warming, or ceremonial purposes, which is not more than three feet in diameter by three feet high, and has had the ground five feet from the base of the fire cleared of all combustible material);
 - B. Open fires;
 - C. Open Burning of vegetation or rubbish; and,
- D. Any other smoke producing substance and material that creates a fire safety hazard. (Reference Regulation #301 of the Ambient Air Quality Standards and Air Quality Control Regulation);
 - E. Trash Barrel Burning;
 - F. Agricultural Burning.

Section 3. ENFORCEMENT

The Sheriff's Department of Valencia County, the Valencia County Fire Department, the Valencia County Code Enforcement Office and any other legally qualified law enforcement officer or any of their agents shall have the ability to enforce this Ordinance.

Section 4. **PENALTIES**

Any violation of this Ordinance shall be deemed a misdemeanor and punishable by a fine of not more than three hundred dollars (\$300) and/or up to 90 days in jail.

Section 5. **SEVERABILITY**

If any article, section or provision of this Ordinance is deemed invalid or void, the remaining portions shall not be effected and shall be enforced accordingly.

Section 6. EFFECTIVE DATE; REPEAL

- The Board of County Commissioners hereby declares a continuing emergency relating to fire conditions within the County, which is an immediate danger to the public health, safety and welfare of the County and its residents, and the ordinance shall take effect immediately upon adoption by the Board of County Commissioners and recordation by the County Clerk as required by statute. Due to the declared emergency and danger, no publication is required pursuant to NMSA 1978, Section 4-37-7 (c) (1981).
- This Ordinance shall be in effect indefinitely until rescinded when favorable conditions exist, as determined by the Fire Chief.
