Welcome and Introductions

Presentation by Louis Pacias on DMC: Presented background and experience. Has seen a lot of different trends in DMC. Explains what DMC is. Racial ethnic disparities is another term for DMC. Louis gives example which occurred during a ride along with law enforcement to clarify. Looks for systems, entries and exits. Looks at populations being arrested. Sometimes population mirrors arrests data and sometimes it does not. Louis gives examples from Sandoval County. First step is to match data and look for trends. Discusses strategies to correct DMC issues which arise. They learned the lesson that everyone needs to be at the table; need good data; need buy in from community. Bernalillo County is a model site for DMC. Carlton Liggins brought up a lot of the DMC issues are geographic and kids in outlying areas do not get the same services. Louis spoke to community mapping and what they found through that. County is off to a good start with data provided by Lindsey Lucero. There is usually not consistency in all areas when you find DMC. Consistency is a goal in all areas. Louis took questions from the board members. Carlton said that DMC is not a systems issue but a community issue. Richard Lindahl spoke to the appropriateness of addressing DMC. Sites will be required to address DMC in the RFP. The board receives a combination of state and federal funds, and it is required to address DMC. Richard announced that there will be a webinar on DMC which will be specific to New Mexico.

documents and the process itself. Need volunteers still. Will organize a volunteer training at YDI to cover

next teen court. Thanks all for support. Will open up to all schools and will move training from SODA to YDI so

it does not appear to be school specific. There will be a waiting list. It is a commitment from both youth and their
