- Presentation by Michael Hock from CYFD on Reclaiming Futures and the \$3,000,000 grant application submitted By CYFD for Valencia County and Chavez County: Michael presented a PowerPoint presentation to the board covering: Seven Challenges, Sat-Ed grant, Gain screening tool, Team approach, substance abuse and co-occurring disorders. Grant will provide support services, recovery services, transportation, experiential therapy, treatment, job training, educational services and life skills. He also discussed the Reclaiming Futures model and how it works.
