George Moscona invited and encouraged the Commission and the public to attend Health Care forum discussion, Saturday, July 25, 2009 at La Merced Elementary (Rio Communities).

<u>Clark Metcalf</u> discussed the importance of having a hospital in Valencia County.

Chairman Rael contacted Commissioner Holliday to be present by via telephone.

County Clerk Sally Perea administered the oath for those wishing to give testimony.

- 5. Public Hearing Item
  - a) Ordinance 2009-02, Adopting a County Correctional Facility Gross Receipts Tax". An excise tax equal to one-sixteenth of one percent (.625%) or one-eighth on one percent (.125%) of the gross receipts reported. In pursuant to the County Correctional Facility Gross Receipts Tax Act as it now exists or as it may be amended and shall be known as the "County Correctional facility Gross receipts tax will be used for the purpose of operating, maintaining, constructing, purchasing, furnishing, equipping, rehabilitating, expanding or improving a Judicial-Correctional or County Correctional Facility, including acquiring and improving parking lots, landscaping or any combination of foregoing; Transporting or extraditing prisoners, to payment of principal and interest on revenue bonds or refunding bonds issued pursuant to the provisions of the County Correctional Facility Gross Receipts Tax Act County Commission

Janet Quigley, Bob Gostischa, William Dean, Clark Metcalf, Alice Torwirt, Leroy Cordova, Attorney Greg Gaudette, Lee Cordova residents of Valencia County, employees of Correctional facility, representatives of inmates requested that the Commission vote in favor of the tax to improve safety, overcrowding but to put forward for public vote.

Board discussed the importance of presenting the purposed tax to the public and having the public decide whether to proceed with a special election and the safety issues for employees and inmates.

Correctional Detention Center Derek Williams gave a brief overview of the Detentions needs and intentions for expansion and opened it up for any questions. The Board reviewed at length past discussions that lead to continue the County Correctional Facility Gross Receipts Tax and the requirements of registered voters to

petition for a public vote.

Commissioner Gentry amended to take public vote, 1/8 cent tax for the Correctional facility without a sunset clause. Seconded Commissioner Medina. Roll call vote. Commissioner Medina voted yes. Chairman Rael voted no. Commissioner Gentry voted yes. Commissioner Kirkham voted no. Commissioner Holliday voted no. Motion fails 3-2.

Chairman Rael made a motion to enact the Ordinance with 1/8 cent tax, without a sunset clause but takes effect unless the public presents the number of signatures and placed to the voter on a public ballot. Seconded by Commissioner Kirkham. Roll call vote. Commissioner Medina voted no. Chairman Rael voted yes. Commissioner Gentry voted no. Commissioner Kirkham voted yes. Commissioner Holliday voted yes. Motion carried 3-2. (See Exhibit A)

County Clerk Sally Perea announced Ordinance 2009-02.
