- 1) The meeting was called to order by Chairman Donald Holliday at 5:00 P.M.
- 2) Chairman Holliday led the Pledge of Allegiance.
- 3) Approval of Agenda.

Commissioner Rael moved for approval of the agenda. Seconded by Commissioner Otero-Kirkham. Motion carried unanimously.

4) Approval of Minutes: May 12, 2010- Public Hearing

Commissioner Medina moved for approval. Seconded by Commissioner Otero-Kirkham. Motion carried unanimously.

May 19, 2010-Business Meeting

Commissioner Medina moved for approval. Seconded by Commissioner Otero-Kirkham. Motion carried unanimously.

5) PUBLIC COMMENTS – At the Discretion of the Chair. (For Information Only-limited to two minutes per person on subjects not on this published agenda).

Meadow Lake resident Bob Gostischa thanked Chairman Holliday for repairs on the road in Mr. Gostischa's area.

Tierra Grande resident Sue Moran said she read the new county solid waste collection ordinance, stated her concerns and briefly spoke on each issue.

#### 6) NON-ACTION ITEMS;

#### a) Presentation "FEMA Update" - Bill Borthwick

Mr. Bill Borthwick updated the commission on the new flood maps that the county will be receiving and explained the process for adopting the flood rate maps by the communities. FEMA (Federal Emergency Management Agency) looked at the State of New Mexico map moderation program and started the digital countywide flood insurance rate maps study process in 2003. The process was a two year process that started in August 1, 2009 for developing new flood hazard data and revising existing data. The effective date for the county to adopt the flood insurance rate maps is August 19, 2010 which would legally endorse the good faith of the community to get involved in the new maps.

c) Reports from Boards, Commissions & Committees- County Commission.

Chairman Holliday thanked Bob Gostischa, Jim Lane, Dee Miramontes, Cyndi Sluder and residents for going out and helping to pick up trash in the Meadow Lake area. Chairman Holliday also stated he made a trip to the Conejo dump grounds and from the time he pulled up to the time he pulled out on a Saturday to dump half a truck load of trash, it took one hour and twenty minutes. So it's very important that the county wide trash collection get moving.

#### 7) ACTION ITEMS:

#### BOARD OF COUNTY COMMISSION CONVENES AS CANVASSING BOARD TO:

a) Begin Canvass of the 2010 Primary Election – Sally Perea
Commissioner Medina moved to convene as the Canvassing Board

Commissioner Medina moved to convene as the Canvassing Board. Seconded by Commissioner Gentry. Motion carried unanimously.

County Clerk Sally Perea stated by state law the commission is ex-officio the canvassing board in each county and shall meet within three days after the primary election to proceed to canvass the returns of the primary election. As per 1-13-12 the canvassing board shall not adjourn until it has canvassed all the returns of the election. The county clerk has ten days from the date of the election to complete and declare the results and is requesting that the board meet on June 9<sup>th</sup> for the final canvassing. Commissioner Gentry motioned that the commission instruct the county clerk to proceed with the canvass and the final canvassing to be held at the next county commission meeting on June 9, 2010. Seconded by Commissioner Rael. Motion carried unanimously.

Ms. Perea gave a brief update on the election day results; There were 41 Provisional Ballots, 1,239 absentee ballots were requested, 1092 absentee ballot were returned, a little over 100 ballots were not returned, runners were sent out to collect the cartridges from most precincts which made the numbers available by 8:30 PM, and voter turnout was 35%. Ms. Perea said it was a good election, with no problems and staff had done an excellent job.

Commissioner Rael moved to re-convene as the Board of County Commissioners. Seconded by Commissioner Otero-Kirkham. Motion carried unanimously.

#### b) Accept Findings of Facts and Conclusions of Law

Consideration of Appeals on an Approved Variance on Side Yard Setbacks in a Suburban Residential (SR) Zoning District to Allow for a Five (5) Foot Side Yard Setbacks; Section 7N, T3E NMPM; Lots 55B1 thru 71B1, Lots 117B1 thru 121B1, Lots 162C1 thru 199B1, Lots 203A1 thru 208A1, Lot 209B1, Lot 210B1 and Lots 211C1 thru 217C1 Eastland Hills Subdivision, Survey Plat M-112 of the Office of the Valencia County Clerk, NM APL#10-004/Cypress Estates Limited Partnership- Jacobo Martinez.

Commissioner Gentry moved for approval. Seconded by Commissioner Otero-Kirkham. Motion carried unanimously. (SEE EXHIBIT A)

# c) Consideration of Joint Powers Agreement with the Town of Peralta-Kenneth Griego.

Assistant County Manager Kenny Griego presented the request to extend the joint powers agreement with the Town of Peralta for one more year. The county is currently assisting the Town of Peralta in the nuisance abatement, platting, building inspections, rural addressing functions as well as road maintenance to include but not limited to roads that were maintained by the county prior to Peralta becoming a municipality.

Commissioner Otero-Kirkham moved for approval. Seconded by Commissioner Rael.

Commissioner Gentry had concerns as to what the costs to the county were in regards to the Joint Powers Agreement and asked Financial Director Wilma Abril which she stated that they really don't know. Commissioner Gentry stated at some point the county needs to know how much the cost is to subsidize the Town of Peralta.

Commissioner Otero-Kirkham stated Section A-1 of the contract reads that functions performed by the county, the sum of \$8,400 would be paid to the county by the Town of Peralta. She asked if the county had received that and Ms. Abril's response was no the county had not.

City Clerk Arturo Saiz from the Town of Peralta stated they appreciate the support that they have received from Valencia County, and in regards to the Joint Powers Agreements the City of Peralta has put aside \$13,200 for animal control for this year's budget. They're willing to pay their part and at this point they're 80% on the third phase of the corporation process. Ms. Abril stated the Town of Peralta pays \$1,100 a month to the county for animal control services.

Chairman Holliday stated 6-A-2 reads "usual and customary maintenance of those roads, culverts and bridges previously dedicated to and previously maintained by the county, Peralta agrees to pay all costs incurred by the county for said maintenance upon prior approval". Whether the county is sending a bill or not, they have agreed to pay for everything. Chairman Holliday agrees with Commissioner Gentry that the county needs to keep track of this and the county needs to send the Town of Peralta a bill.

Commissioner Gentry asked Ms. Abril to research what the costs to the county have been before they do another year.

Motion carried 4-1. Commissioner Gentry voted no. (SEE EXHIBIT B)

# d) Consideration of Resolution 2010-26, Prohibiting County Officials from Placing Their Names on County Vehicles-Kenneth Griego.

Commissioner Otero-Kirkham stated this was as a result of the sheriff having his name on the sheriff's vehicles. So is he going to be grandfathered in, is he going to be asked to remove his name or is it that from now on, a name cannot be placed on a vehicle? Commissioner Holliday said he was not sure how to answer and this is why it was up for discussion.

Commissioner Rael said the county can have a policy that county elected officials cannot place their names on cars, signs or anything. What concerns Commissioner Rael is that the county already has names on county vehicles and are we going to compel payment for the names to be removed, is that an ex post facto law, do we have a problem with that principle?

County Attorney Dave Pato had prepared this resolution based on the terms of the last commission meeting and for that very reason he included "effective prospectively", which means for the future.

Commissioner Otero-Kirkham moved for approval. Seconded by Commissioner Gentry. Motion carried unanimously.

County Clerk Sally Perea announced Resolution 2010-26. (SEE EXHIBIT C)

e) Consideration of Revised Cooperative Agreement with NMDOT to Provide Real Estate Services for Highway Safety Improvement Program (HSIP) for Meadow Lake Rd from Manzano Expressway to High Mesa Rd. –Eric Zamora.

Chairman Holliday moved for approval. Seconded by Commissioner Rael. Motion carried unanimously. (SEE EXHIBIT D)

f) Consideration of revised North Central New Mexico Economic Development District Non-Metro Area Agency on Aging Vendor Agreement-Kenny Griego.

Commissioner Otero-Kirkham moved for approval. Seconded by Commissioner Rael. Motion carried unanimously. (SEE EXHIBIT E)

Commissioner Otero-Kirkham moved for approval. Seconded by Commissioner Rael. Motion carried unanimously.

Commissioner Medina moved for approval. Seconded by Commissioner Gentry. Motion Carried unanimously.

Commissioner Rael moved to approve the summary as stated by counsel. Seconded by Commissioner Gentry. Roll call vote. Commissioner Medina voted yes. Commissioner Rael voted yes. Commissioner Gentry voted yes. Commissioner Otero-Kirkham voted yes. Chairman Holliday voted yes. Motion carried 5-0.
