

- 1) The meeting was called to order by Chairman Holliday at 9:30 A.M.
- 2) Chairman Holliday led the Pledge of Allegiance.
- 3) Approval of Agenda

Commissioner Andersen moved for approval of the agenda. Seconded by Commissioner Otero-Kirkham. Motion carried unanimously.

4) Approval of Minutes: January 4, 2012 Business Meeting January 11, 2012 Public Hearing Meeting

Commissioner Romero moved for approval of the minutes of January 4, 2012 Business Meeting and January 11, 2012 Public Hearing Meeting. Seconded by Commissioner Otero-Kirkham. Motion carried unanimously.

PRESENTATION(S)

5) Los Lunas School Bond Election – Bernard Saiz, Superintendent, Los Lunas Schools Los Lunas School Superintendent Bernard Saiz came before the commission to request their support and ask for the support of the community for the school bond election being held on February 7, 2012. If the bond is passed it will allow the Los Lunas School District to create bonds that can be sold later for money to improve the schools and their technology.

Los Lunas Schools Chief Finance Officer Claire Cieremans stated the bond is a four year cycle. Every four years they go back out to the voters to ask for their approval. This comes with no tax increase; this is just a continuation of the tax but is required to present it to the voters every four years on the bond election and five years on the 3 Mill.

Assistant Superintendent of Curriculum Instruction and Technology Ron Williams said what the 3 Mill entails for the Los Lunas Schools in terms of dollars is 2.7 million a year or about 13.5 million dollars. There's no way that the schools operational budget could sustain that if this wasn't passed.

6) Employee Recognition - Kenneth Griego / Lawrence Esquibel

County Manager Eric Zamora gave recognition to Business Manager Kenneth Griego as this is his last week of employment with the county. Mr. Zamora thanked Mr. Griego for all the work he's done, for the help he has provided to Mr. Zamora, as Mr. Griego's experience has been valuable, primarily in his ability to communicate with people and become part of a working environment.

The commission also expressed their gratitude to Mr. Griego.

Mr. Zamora also recognized IT Director Lawrence Esquibel who earned the title as a Certified Public Official at the New Mexico Association of Counties Conference. Commissioners all congratulated Mr. Esquibel on his accomplishment.

Discussion (Non-Action) ITEM(S)

7) Department Reports-IT -Tyler Update- IT Director Lawrence Esquibel updated the commission on the Tyler conversion project. Department heads staff has been working tirelessly to produce the client surveys required before scheduling the conversion dates can be set for all the departments. Conference calls are held weekly between Valencia County IT staff and Tyler Project Manager Paula Wilkenson, Shauna Swenson and Jennifer LaForge in which the current status and needs of the implementation project are discussed.

Minutes of January 25, 2012, Regular Business Meeting

The county will go live on all the financial applications by the middle of August. The calendar of scheduled encode conversions are in place, the calendar of conversions for the clerk, assessor and treasurer's office is tentative at this point but will be solidified by weeks end. In general they are looking at August for a go live time frame for the assessor, September for the treasurer and July for the clerk's office. This is based on the Tyler's conversion staff's availability. In regard to the infrastructure implementation they are moving along nicely, Tyler databases and application servers should all be in place by the 6th of February and the desktop replacement will begin around the 13th of February and the first of the Tyler needed servers are scheduled to be in place by February 6th.

8) Reports from Manager, Commissions, Boards & Committees

County Manager Eric Zamora said at the last meeting a county resident brought information to the commission in regard to one of the county's haulers and their payment status and some issues were found with the payment on that one hauler. That hauler begins a cycle paying quarterly rather than monthly. The payments are required to be made monthly and there were a series of payments last year that were made on a quarterly basis. For the two months that were not identified in that quarter, there was no payment shown, however they were made that third month. At the next commission Mr. Zamora will provide an update for all of the registered haulers.

Information from the Department of Transportation has been received requesting the county's participation in the 2012-2013 local government road fund cooperative program. This is the Cap Co-op and School Bus Program. The project requests are due at the Department of Transportation by March 15, 2012 and will meet with the commissioners individually to identify the road needs in each of their districts and prepare the estimates and get them back to the DOT with a recommendation.

Mr. Zamora updated the commission on some of the concerns discussed while attending the Association of Counties Conference. One of the primary concerns was state revenues and the value of natural gas sales in the state. Budget figures for the state were prepared on a \$5.00 per unit cost for natural gas and the current pricing is just under \$3.00 per unit. Every dime dropped in that price of natural gas impacts the state to the tune of about \$13,000,000.00. The Association of Counties Legislative priorities for 2012 are the following: 1) Hold Harmless (when the state did away with the food tax there was concern with the local government that it would have a significant impact on revenues that would not make it down to the local level. The state supplemented that fund with additional money and there is talk abut eliminating that funding.) Mr. Zamora asked the community to speak to the legislators to support the Hold Harmless and keep the revenues coming down to the local level; 2) The Fire Works Ban, currently state statute does not provide counties the ability to enforce the fire works ban within the incorporated areas, this would empower the county to enable that fire works ban if needed; 3) Poll Workers who are PERA retiree's takes them into the double dipping issue. A PERA retiree is now ineligible to work for another PERA paying entity such as county elections will be eligible to work without it affecting their PERA retirement; 4) Decriminalization of traffic violations; 5) Gross Receipts Codes, identifying where those gross receipts taxes are to be paid to in order to distribute to the appropriate entities.

Heritage Preservation month is coming up and in alignment with the states centennial anniversary, the State Historic Preservation Division is requesting images for their centennial poster. These images should reflect New Mexico's Statehood over the last 100 years and the deadline to submit those images is February 24, 2012.

Mr. Zamora introduced the county's new Procurement Specialist, Mike Vinyard whose background includes working with the State of New Mexico, and serves on the National Association of State Procurement Officials for the 8 years as the state purchasing agent. Mr. Vinyard, has been in the job for a month and sees many opportunities of saving money for the taxpayers and making the system work better.

Commissioner Gentry had the opportunity to visit with Senator Udall on getting Federal Stimulus Funding for Jarales and Highway 304, the two railroad crossings in the southern part of Valencia County. Senator Udall was very positive and agreed that hopefully they could tap into what's going to be coming out as far as stimulus jobs. Both projects are pretty well shovel-ready but just have not found the funding to complete. The Senator has instructed his staff to start working on this. Commissioner Gentry also met with State Representative Baldonado on road funding for the county.

Chairman Holliday asked Mr. Zamora to look into the error with collections from the one particular hauler and get it corrected so the county doesn't lose any revenue. Chairman Holliday also asked for an update on the Adult Detention expansion.

Mr. Zamora said they have entered into a settlement agreement and the final documents have been sent to the contractor. The settlement is complete with the exception of the delivery of the metal building which is still at the supplier's and he prefers that it remain there until it is needed. Mr. Zamora is anticipating delivery of the contract to move forward with the project to the commission by next Wednesday. The project at this stage is at about 95% designed, what it did not include because it was a design built project was a design book to go out to prospective bidders. They will be designing a specification booklet and once that's done, it should be no more than thirty days to get the package ready for bid. Mid-March is the anticipated bidding date.

Ms. Barbara Baker presented the Indigent Claims from December 8, 2011 to January 12, 2012 and requests approval of \$70,703.50.

Commissioner Andersen moved for approval. Seconded by Commissioner Otero-Kirkham. Motion carried unanimously. (See Exhibit A)

Ms. Baker presented an appeal for Ms. Tamara Wood in the amount of \$19,941.55 and requested approval of \$3,000.00 to be paid to UNM Health Sciences Center.

Commissioner Andersen moved for approval. Seconded by Commissioner Otero-Kirkham. Motion carried unanimously. (See Exhibit B)

Commissioner Otero-Kirkham motioned to re-convene as Board of County Commissioners. Seconded by Chairman Holliday. Motion carried unanimously.

10) Consideration of Appeal for a Conditional Use for a Solar Facility in a Mineral Resource Zone. T6N, R2 & 3E, Section 1 & 6; NMPM, Lands of Orona Investments, Tract 1, Zoned M-R Filed in Book 341 page 8242 of the Office of the Valencia County Clerk – Eric Zamora / Jacobo Martinez.

Commissioner Andersen stated as much as she believes in Solar Energy and opt for other ways of raising energy other than gas fired plants, oil or coal, she believes the Planning and Zoning Commission made an error. The proposed use is neither a permitted use nor a permitted conditional use in an M-R District. Section 154.09 C8 in our county zoning ordinance provides that utility facilities with the exception of energy generation facilities are a permitted conditional use. The proposed solar array is an energy generation facility. Solar panels use light energy or photons from the sun to generate electricity through the photovoltaic effect. The applicant proposes to use these solar panels to generate and supply electricity in commercial and residential applications. As energy generation facility the proposed use is not a permitted conditional use in an M-R District. Commissioner Andersen moved that the commission reverse the Planning and Zoning Commissions approval of a Conditional Use for a solar facility in a mineral resource zone.

Commissioner Romero said he is also for clean industry and thinks everyone here feels that this type of project is worth all the consideration they can give it. It is the location that is the problem and in this case he feels the commission has to put people over profits. The people of this community showed him that the facility overly intrusive and that the quality of life and home values would be greatly diminished. He has received more citizen requests on this zoning issue than all the others combined. So with this he would agree with Commissioner Andersen and will second her motion. Motion carried unanimously. Chairman Holliday said to clear the confusion, this commission has voted to reverse the decision of the Planning and Zoning Commission and to deny the appeal. The commission is saying "no" to the solar plant in that location.
