- 1) The meeting was called to order by Chairman Holliday at 10:00 A.M.
- 2) Chairman Holliday led the Pledge of Allegiance.

Commissioner Otero-Kirkham moved for approval of the agenda as amended. Seconded by Commissioner Gentry. Motion carried unanimously.

ACTION ITEM(S)

4) Consideration of Approval of Census for Rio Communities Incorporation – Mark Gwinn

Mr. Gwinn said this is a request to allow them to begin the process with the county to move forward toward their incorporation. They have provided the petitions to be certified, the boundary map of the area to be incorporated and have also asked the commission to accept the 2010 census as it reflects the body of the incorporation. At this time they would like to start the process to allow them to have an election to be held in January.

Commissioner Romero motioned to accept and allow the petition for the Rio Communities Incorporation to be utilized, use the 2010 U.S. Census for incorporation and the census results accepted once they are dealt with the Board of County Commissioners. Seconded by Commissioner Gentry. Motion carried unanimously.

County Attorney Adren Nance said what the statute requires that generally they deposit money for the payment of the census and what we said here is that we are not going to pay for that census; we are going to utilize a different census. So that then means that at a later time they will file the results of that census with this board and then that will start a different process. We'll wait for that to happen at a different time once it's filed and the next step in the process will start. That's where we're at.

5) Resolution 2012-28, Adoption of 2012 Tax Rates – Viola Vallejos/ Orlando Montoya. Mr. Montoya stated the County Treasurer has received the 2012 property tax rates mandated from the Department of Finance Administration and will need to get this imposed in order to get the tax bills out in November. Tax rates did see a modest decrease.

Commissioner Otero-Kirkham moved for approval. Seconded by Commissioner Gentry. Motion carried unanimous.

County Clerk Sally Perea announced Resolution 2012-28. (SEE EXHIBIT A)

VALENCIA COUNTY BOARD OF COUNTY COMMISSIONERS RESOLUTION NO. 2012-29

A RESOLUTION ORDERING THE IMPOSITION OF THE 2012 PROPERTY TAX RATES AS REQUIRED BY LAW

WHEREAS, the Board of County Commissioners of Valencia County, New Mexico, at a Special Meeting on September 10, 2012, deem it necessary to approve the 2012 Tax Rates as set forth in the certification issued by the Department of Finance and Administration; and

WHEREAS, NMSA 1978, Section 7-38-34 (1973) provides that "[w]ithin five days of receipt of the property tax rate-setting order from the department of finance and administration, each board of county commissioners shall issue its written order imposing the tax at the rates set on the net taxable value of property allocated to the appropriate governmental units. A copy of this order shall be delivered immediately to the county assessor."; and

WHEREAS, on September 6, 2012, the County of Valencia received the 2012 property tax rate-setting order from the department of finance and administration; and,

WHEREAS, the imposition of Property Tax Rates pursuant to Section 7-38-34, and by the 2012 Certificate of Tax Rates are hereby certified as the Tax Rates for the Government units sharing in the tax in accordance with the property tax code.

NOW, THEREFORE, BE IT RESOLVED, that the Board of County Commissioners of Valencia County hereby approve and implement the aforementioned 2012 Certificate of Tax Rates, attached hereto.
