WORKSHOP

1) The meeting was called to order by Chairman Eaton at 2:03 P.M.

2) Commissioner Romero led the Pledge of Allegiance.

3) Approval of Agenda

Commissioner Aguilar moved for approval. Seconded by Commissioner Aragon. Motion passed 4-0. Commissioner Andersen was not present for the workshop portion of the meeting.

WORKSHOP

4) Conejo Transfer Station Funding

Ms. Bouska stated that by December 31, 2013 the entire FY 13-14 funding will be exhausted. Since a decision has not yet been made by District Court on the Waste Management contract we are anticipating having to fund Conejo until June 30, 2014. The bottom line is that we need \$102,606 to fund Conejo until the end of the fiscal year.

Option #1 is to make a budget adjustment in Public Works from the road construction budget, but by doing that it will cause a budget shortfall in other areas of the Public Works Department.

Option #2 is a budget adjustment in Public Works with the construction project budget, this money is created from the general fund and gives the commissioners additional funding for their road projects. If money is taken from this fund any road project requests that the commissioners may have will likely be put on hold.

Option #3 is increasing tipping fees at Conejo, the current tipping fees only account for 84% of what it costs the county for disposal. To increase the tipping fees it would require the commissioner's approval and there may be possible public disapproval of the increased costs and the increase may lead to more illegal dumping. One option is to use a fee chart similar to Torrance County's or to actually measure out each load that is brought in; we can tailor the fees to meet our needs.

Option #4 would be to reduce the number of days that Conejo is open. On the days that it is closed the employees from Conjeo would be transferred to other areas within Public Works. This option would bring reduced operation and maintenance costs. Commissioner Aguilar commented that she believes that the additional closures would bring negativity from the public. Ms. Bouska stated that it may also bring about more illegal dumping as well.

Option #5 is recycling efforts; the county would need to cancel the MOU with the City of Belen and would also need additional money to construct the necessary facilities for the recycling effort.

Commissioner Aguilar thanked Ms. Bouska for the different options that were presented, but she personally would not like to give up her road money. She has not had any road money for this whole year and people are waiting for some road repairs. Ms. Bouska stated that she doesn't personally have a recommendation, she is given a budget for each of her departments and her goal at the end of the year is to be within budget. Ms. Bouska stated that with the commissioner's approval increasing the tipping fees could be implemented immediately. Mr. Telles commented that when other counties or

municipalities are faced with situations similar to this they look at capital outlay or capital expenses such as overtime, training, and travel per diem. He knows it is hard but difficult decisions do need to be made. Mr. Telles stated that to him the easiest decision would be to take the money from construction in capital outlay. Because if you raise the prices you may run into fewer people using the transfer station. Commissioner Aguilar commented that people are calling her because no road work has been done around her district, she hasn't had money. But now in this second year she is getting some money to do some road repairs, but you're asking her to go two years without anything. The roads are very different from solid waste; they are two separate independent matters. If she gives up her road money and solid waste gets solved in 2 or 3 months she still won't have any money because it's the end of the fiscal year.

Chairman Eaton stated that he sees pros and cons with each issue; we can be quick to fix one problem but create another one in the process. He went on to say that he is not ready to make a decision on this issue yet, he needs to look into it a little more and get feedback from some of his constituents. Commissioner Aragon remarked that he believes by just raising the tipping fees it will create a bigger issue with illegal dumping. Mr. Telles stated that they would need guidance soon because he doesn't know how they will fund Conejo starting in January and there are bills that need to be paid. Commissioner Aguilar commented that this item is an action item on the agenda for the business meeting later tonight, that's why she wanted to move forward with this and have a conversation because this is getting addressing in as little as 2 hours. We don't have another meeting this year and the budget cuts off on December 31st, we need to have this figured out. Commissioner Aragon asked if all the commissioners had the same amount of money for their road projects. Ms. Bouska replied yes all commissioners have \$40,000 in this year's budget; the money is earmarked from the general fund. Chairman Eaton asked what the public notice timeframe would be to inform the public of a possible tipping fee increase. Attorney Nance stated that a 20 day notice period would be required with 1 public hearing. (See Exhibit A)

The contract had been previously executed by the previous commission, the court's ruling will be either that the procurement is valid therefore the contract is valid and will be implemented as is or they can rule that the procurement was invalid therefore the contract will not be valid.

Chairman Eaton called for the vote on the motion and the second. Motion passed 4-1. Chairman Eaton voted no. (See Exhibit G)

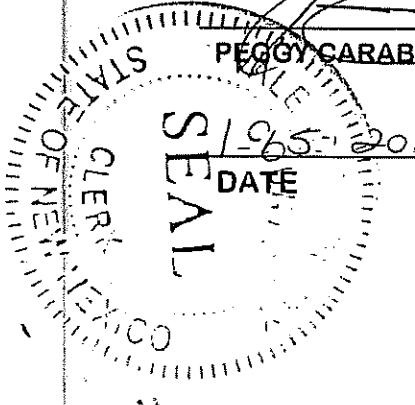

CONEJO FUNDING OPTIONS FOR FY 2013-2014

SUMMARY

It was anticipated that the Conejo Transfer Station would be turned over to Waste Management as part of their contract some time during FY 2013-2014. As a result, the Conejo facility was only partially funded for the current budget cycle. As of November, 2013, the facility is still managed by Valencia County. Currently, there is funding to continue its current 5-day operation through December 2013.

We are anticipating retaining the facility through the end of the fiscal year. Therefore, additional funding is needed to continue to maintain the existing level of service being provided at Conejo.

Needed funds are indicated below:

In addition to the operating expenses, the projected revenues from Conejo were also under-budgeted during the current budget cycle. It is estimated that Conejo will provide an additional **\$146,156** through tipping fees collected at the facility. These funds will be used to offset the operational costs. Taking into account the estimated expenses in addition to the additional revenue and budget adjustments, the Solid Waste budget is currently underfunded by an amount equal to **\$102,606**.

There are currently a number of options available to fund this amount. These options may be exclusive or combined.

OPTION 1: BUDGET ADJUSTMENT WITHIN PUBLIC WORKS FROM ROAD CONSTRUCTION

Advantages:

- Money can be moved within the Public Works Division during the mid-year budget adjustments.
- The entire amount (\$102,606) can be found within the existing Road Construction budget.

Disadvantages:

- There has already been a budget adjustment of \$42,500 from this account into the Trash Disposal line item to cover these costs through the end of the second quarter. If an additional \$102,606 is

adjusted out of this account, the total adjusted amount (\$145,106) will amount to 48% of the approved budget for this line item.

- This line item is used for all types of road maintenance activities, including the purchase of hot/cold mix for pothole repairs; salt and cinder mix for snow removal; and millings, base course, and gravel for road repairs.

AVAILABLE FUNDING = \$102,606

OPTION 2: BUDGET ADJUSTMENT WITHIN PUBLIC WORKS FROM CONSTRUCTION PROJECT

Advantages:

- This fund is created from the General Fund and gives the Commissioners additional funding for their individual project.
- Money can be moved within the Public Works Division during the mid-year budget adjustments.
- The entire amount (\$102,606) can be found within the existing budget.

Disadvantages:

- Requested projects from each County Commissioner may be placed on hold for lack of funding.
- A budget adjustment of \$102,606 from the Construction Project line item will reduce the remaining budgeted amount to \$52,015.

AVAILABLE FUNDING = \$102,606

OPTION 3: INCREASE TIPPING FEES AT CONEJO

Advantages:

- Solid waste disposal moves toward becoming a self-sustaining operation.
- Funding through other County programs is not required.
- Savings of \$8,089 to \$162,341 (dependent on option) annually could be realized and directly used to offset costs at Conejo.

Disadvantages:

- Increasing the current tipping fees would require Commission approval.
- Possible public opposition to an increase in the tipping fees.
- Illegal dumping may increase as a result of increased tipping fees.

AVAILABLE FUNDING = \$4,044 to \$81,170 (based on a 6-month savings from January to June)

OPTION 4: REDUCE THE NUMBER OF DAYS CONEJO IS OPEN

Advantages:

- Once communicated, the reduction in open days can be immediately implemented.
- Employees would be transferred to work within other areas of Public Works on the additional closure days.
- Reduce equipment operating and maintenance costs
- There would be an estimated reduction in annual costs at Conejo of \$35,000 to \$50,000 for every day per week Conejo is closed.

Disadvantages:

- Operational savings would include only diesel fuel costs, trash disposal costs, and equipment maintenance/repair costs. Labor and benefits would still need to be covered through additional budget adjustments.
- There could be an increase in public disapproval resulting in increased illegal dumping.

AVAILABLE FUNDING = \$17,500 to \$25,000 per closed day (for remaining ½ of fiscal year)

OPTION 5: RECYCLING EFFORTS

Advantages:

- An immediate cost savings related to disposal for each ton of waste diverted. Plus an additional savings related to fuel and equipment/repair costs.
- Savings are estimated to be approximately \$600/month once the Belen MOU is cancelled. There would be \$350/month in disposal savings, plus a 5% reduction in operational costs. These savings are estimated to increase as public participation increases.
- Recycling diverts wastes that cause management problems, such as cardboard .
- There are grant funding sources available to assist with initial startup costs.
- There is an opportunity to build cooperative efforts with other local entities.
- Valencia County can begin to satisfy public requests for recycling in addition to our existing scrap metal/appliance program.

Disadvantages:

- Approximately \$4,000 is needed to construct a concrete pad for collection containers and a block wall with wire fencing to keep unsecured paper and cardboard from becoming a litter nuisance.
- Operational savings would include only diesel fuel costs, trash disposal costs, and equipment maintenance/repair costs. Labor and benefits would still need to be covered.
- Savings are dependent on the amount of public participation.
- Requires consideration in Procurement Department's Disposal Plan.

AVAILABLE FUNDING = \$7,000 (based on anticipated savings for February – June)

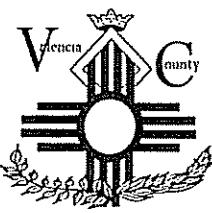

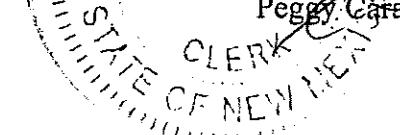

FINDINGS OF FACT, CONCLUSIONS OF LAW AND DECISION

THIS MATTER came before the Board of County Commissioners of Valencia County ("the Board") on November 13, 2013, and was held pursuant to the applicants James H. Johnson's application to Amend the Zoning Map from a Rural Residential-2 (RR-2) zoning designation to a Community Commercial (C-2) zoning designation on the property commonly described as: T6N, R1E, Section 36, NMPM; Map 92; Lands of Roy Lemons; Tract 4; Zoned RR-2; Filed in Book 321, Page 8,685 of the office of the Valencia County Clerk.

The Board, having considered the documents in the record before it, testimony of staff, applicants and members of the public, and argument by the parties and/or their legal representatives, **FINDS:**

Findings of Fact

1. Notice of the regularly scheduled meeting of the Board of Commissioners of Valencia County, New Mexico (the "Board") on November 20, 2013, at which the final hearing of the Application to Amend Zoning Maps was published according to New Mexico Statutes and the Valencia County Interim Comprehensive Zoning Ordinance, Ordinance 2004-05, as amended ("Zoning Ordinance").
2. The applicant's request is for an amendment to the Zoning Map from a Rural Residential-2 (RR-2) zoning designation to a Community Commercial (C-2) zoning designation on the property commonly described as: T6N, R1E, Section 36, NMPM; Map 92; Lands of Roy Lemons; Tract 4; Zoned RR-2; Filed in Book 321, Page 8,685 of the office of the Valencia County Clerk.
3. Approval of the application may result in allowing an indoor recreational facility on the subject property.
4. The property for which the zone change is requested has a Rural Residential-2 (RR-2) zoning designation.
5. The purpose of the Rural Residential Districts is to provide for varying densities of rural residential development on selected lands identified in the comprehensive plan for preservation of low density rural living.
6. The proposed use is not permitted in the Rural Residential-2 (RR-2) zoning district.
7. The purpose of the Community Commercial (C-2) District is to provide for more intensive commercial services than in the C-1 District for numerous neighborhoods in the geographic area.
8. The proposed use is a Permitted Use in the Community Commercial (C-2) zoning district.
9. The Planning and Zoning Commission heard this request at the monthly P&Z hearing on September 25, 2013. After hearing testimony from the applicant and taking public comments on the matter, the P&Z Commission voted 5-0 to recommend approval of the zone change.
10. The Planning and Zoning Commission Found:
 - a. The zone change as described by the applicant is appropriate considering the surrounding land use and pattern development in the area.
 - b. The zone change as described by the applicant enhances the County's protection of public health, safety and welfare.
 - c. The zone change as described by the applicant provides quality public utility that will steer urbanizing development to areas with adequate infrastructure and utility.



- d. The zone change as described by the applicant strengthens the economic base of the County.
- 11. The Board finds the findings of the Planning and Zoning Commission well taken, and adopts them in part.
- 12. The Board of County Commissioners held a Public Hearing on this request on November 13, 2013. After hearing testimony from the applicant and taking public comments on the matter, the Board of County Commissioners voted 5-0 to approve this request on November 20, 2013.
- 13. The subject property is located within a Valencia County Activity Center as defined by the Valencia County Comprehensive Plan.
- 14. The pattern of development in the area includes commercial uses.
- 15. The findings made by the Board are each independent reasons for the decision of the Board in approving the zone change.

Conclusions of Law

The following conclusions of law are cumulative, but are severable and independent of each other.

- A. The County is a zoning authority with the power to regulate and restrict use of land. NMSA 1978, § 3-21-1 (1995).
- B. The Board of County Commissioners is the body that exercises the powers of a county as a body politic and corporate. NMSA 1978, § 4-38-1 (1876).
- C. The Board takes notice that the Zoning Ordinance was adopted according to New Mexico statutory authority and duly recorded in the records of the Clerk of Valencia County.
- D. The Board has discretion in making zoning decisions. *See Singleterry v. City of Albuquerque*, 96 N.M. 468, 471, 632 P2d 345, 348 (1981).
- E. The Board has authority and jurisdiction over the Petition for Zone Change filed by James H. Johnson.
- F. All parties entitled to notice were afforded notice in accordance with the applicable Valencia County Ordinances, New Mexico State Statutes, and common law.
- G. The applicant and the public were afforded due process pursuant to the United States Constitution, the New Mexico Constitution, and in accordance with the applicable Valencia County Ordinances.
- H. The Board takes notice that §154.061 of the Valencia County Zoning Code provides that the proposed zone change should be consistent with the goals, policies and any other applicable provisions of the Comprehensive Plan. As further delineated below, the Board's decision herein is consistent with the Comprehensive Plan.
 - I. The Board takes notice that the Valencia County Comprehensive Land Use Plan of October 7, 2005, ("Comprehensive Plan") is the comprehensive plan applicable to this matter, and was properly adopted according to New Mexico statutory authority.
 - J. Land Use and Housing Development Goal A of the Comprehensive Plan encourages the County to "guide development in a manner that balances the patterns of urban development with the rural character and natural resources of the County."
 - K. Economic Development Goal P of the Comprehensive Plan encourages the County to "strengthen the economic base of the County, expand employment opportunities, and improve local workforce skills and abilities."
 - L. Future development patterns and activity centers encourages the County to accommodate anticipated growth through the development of activity centers. Activity centers are "distinctive areas which would be allowed to attract intensive development with the County's support and assistance."
 - M. Section 154.061 (C) (2) of the Zoning Ordinance provides that "The proposed change [be] appropriate considering...the surrounding land uses, density and pattern of

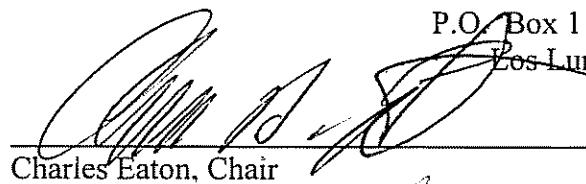
development in the area..." The future land use intended by the Applicant is consistent with the Zoning Ordinance.

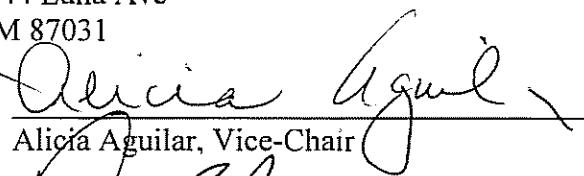

RECITALS.

WHEREAS, NMSA 1978, Section 3-18-1 (1972) provides that municipalities, and also counties pursuant to NMSA 1978, Section 4-37-1 (1995), have the power to "protect generally the property of its municipality and its inhabitants" and to "preserve peace and order"; and

WHEREAS, Section 4-37-1 *et seq.* NMSA 1978 provides that counties may adopt ordinances, not inconsistent with statutory or constitutional limitations placed on counties, to discharge those powers necessary and proper to provide for the safety, preserve the health, promote property and improve the morals, order, comfort and convenience of the county and its inhabitants.

SECTION 1. PURPOSE

This chapter is intended to promote the public health, safety and welfare and to safeguard the health, comfort and living conditions of the citizens of Valencia County, New Mexico due to the air pollution and fire hazards of open burning and outdoor burning.

SECTION 2. APPLICABILITY

This chapter applies to all outdoor burning and refused burning with in the unincorporated areas of Valencia County, New Mexico.

- A. This chapter does not apply to burning in a stove, furnace, fireplace, or other heating device within a building used for human habitation unless the materials being burned include refuse as defined in Section 13.10.005.
- B. This chapter does not apply to the use of propane, acetylene, natural gas, gasoline, or kerosene in a device intended for heating, construction, or maintenance activities.

SECTION 3. DEFINITIONS

The following words, terms, or phrases when used in this chapter, shall have the meaning ascribed to them in this section, except where the context clearly indicates a different meaning.

- A. "Campfire" means a small outdoor fire intended for recreation or cooking; not including a fire intended for disposal of weeds, waste wood or refuse.
- B. "Clean Wood" means natural wood which has not been painted, varnished, or coated with a similar material and has not been pressure treated with preservatives and does not contain resins or glues as in plywood or other composite wood products.
- C. "Fire Chief" means the Valencia County Fire Chief.
- D. "Open Burning" means the burning of materials wherein products of combustion are emitted directly into the ambient air without passing through a stack or chimney from an enclosed chamber.
- E. "Outdoor burning" means any open burning

- F. "Recreational / Bon Fire" means an outdoor fire burning materials other than rubbish where fuel being burned is not contained in an incinerator, outdoor fireplace, barbecue grill or barbecue pit and has a total fuel area of three feet or less in diameter, and two feet or less in height for pleasure, religious, ceremonial, cooking, warmth or similar purposes.
- G. "Refuse" means any waste material except clean wood.

**SECTION 4. GENERAL PROHIBITION ON OPEN BURNING, OUTDOOR BURNING, AND
REFUSE BURNING.**

Open burning and refuse burning are prohibited in the unincorporated areas of Valencia County, New Mexico, unless the burn is specifically permitted by this chapter.

SECTION 5. MATERIALS THAT MAY NOT BE BURNED

The following materials may not be burned in an open fire, incinerator, burn barrel, furnace, stove, or any other outdoor incinerator or heating device.

- A. Rubbish or garbage including but not limited to food waste, food wraps, packing material, animal carcasses or waste, paint or painted materials, furniture, composite shingles, construction or demolition debris, or other household or business waste.
- B. Waste Oil or other oily wastes except oil used in a heating device.
- C. Treated or painted wood including but not limited to, plywood, composite wood products or other wood products that are painted, varnished, or treated with preservatives.
- D. Asphalt and products containing asphalt.
- E. Any plastic material including, but not limited to, nylon, PVC, ABS, polystyrene, or urethane foam, synthetic fabrics, plastic films, or plastic containers.
- F. Rubber including tires, and synthetic rubber – like products.

SECTION 6. BURN BARRELS

No Person shall use or maintain a burn barrel in the unincorporated areas of Valencia County, New Mexico.

**SECTION 7. OPEN BURNING OF LEAVES, BRUSH, CLEAN WOOD AND OTHER
VEGETATIVE DEBRIS.**

Open burning of leaves, weeds, brush, stumps, clean wood and other vegetative debris is allowed only in accordance with the following provisions:

- A. All allowed open burning shall be conducted in a safe, nuisance free manner, when wind and weather conditions are such as to minimize adverse effects and not create a health hazard or visibility hazard on roadways, railroads, or airfields.
- B. Provisions established in Section 8 of this chapter.

SECTION 8.**BURN PERMITS AND RESTRICTIONS**

- A. No person shall start or maintain an open burn without a burn permit issued by the Fire Chief or his designee of Valencia County Emergency Services.
- B. Any person responsible for burning leaves, brush, clean wood, or other vegetative debris under Section 7 shall obtain a burn permit before starting a fire.
- C. Burn permits will be issued by Valencia County Emergency Services by telephone or email correspondence. Any person wishing to obtain a burn permit must contact the Valencia County Fire Administration Office (505) 866 – 2040 during normal business hours, or the Non-emergency Dispatch Line (505) 866 – 2460 After Hours or Weekends for approval.
- D. All burning must take place during the hours of 1 hour after sunrise to 1 hour before sunset. The Fire must be totally extinguished and cold by sundown.
- E. The emission of smoke shall not be allowed to pass onto or across a public road or land strip such that a hazard is created by impairment of visibility.
- F. No open burning of any type shall be undertaken during periods when either: the Fire Chief or National Weather Service has issued an inclement weather warning or burn ban such as a “Red Flag Warning”, or “Fire weather Watch” applicable to the area.
- G. When weather conditions warrant, the Fire Chief may declare a burning moratorium on all open burning and temporarily suspend previously issued burn permits for open burning.
- H. Open burning shall be conducted only on the property on which the materials were generated and permitted for.
- I. Outdoor campfires and small bonfires for cooking, ceremonies, or recreation are allowed; provided that the fire is confined by a control device or structure such as a fire ring or fire pit. Bonfires are allowed only if approved by and in accordance with provisions established by the Fire Chief or his designee.
- J. Open burning shall be constantly attended and supervised by a competent person of at least eighteen (18) years of age until the fire is completely extinguished and is cold.
- K. The person shall have readily available for use, such fire extinguishing equipment that may be necessary for the total control of the fire.
- L. No materials may be burned upon any street, curb, ally, gutter, sidewalk, or public way.
- M. Any infringement of the conditions of a burn permit shall be deemed a violation of this chapter. Any violation of this chapter or burn permit shall void the burn permit and may cause for a suspension of issuance of any future request.
- N. The Fire Chief reserves the right to refuse to authorize a burn permit to any requesting party.

SECTION 9.**UNRESTRICTED BURNING**

No permit is required for open burning for recreational and ceremonial purposes, for barbecuing, for heating purposes, for the noncommercial cooking of food for human consumption and for

warming by small wood fires at construction sites or cooking using charcoal, wood, propane or natural gas in cooking or grilling appliances. Notwithstanding, the types of burning in this Section may be banned pursuant to Section 10 of this Ordinance.

SECTION 10. BURN BAN

- A. The Fire Chief may impose a ban upon any or all types of open fires or contained open fires in the unincorporated areas of Valencia County, New Mexico if it is deemed that danger of forest, grass, or structural fires are found to be high, by competent evidence which may include:
 - i. Any similar ban imposed under the authority of the governor of the State of New Mexico;
 - ii. Any recommendation, or similar ban from New Mexico State Forestry, US Fish & Wildlife, United States Forest Service, New Mexico Middle Rio Grande Conservancy District, or any other service of the federal, state, or local government.
 - iii. Any testimony or exhibits establishing that, due to weather, weather forecasts, or conditions of forest, grass, or other vegetation, the likelihood of a fire is high.
- B. During the time of the ban of contained or open fire, an individual may make a request to Valencia County Emergency Services Fire Chief for an exemption of such ban. After an inspection of the containment structure, surrounding vegetation, and potential fire fuel, and the immediate availability of fire suppression apparatus, the County Fire Chief may exempt from such ban, the open fire or contained open fire.
- C. Notice of such ban shall be given by best means available, including press release, individual notification to any agency requesting or advising in favor of the ban, individual notification to law enforcement agencies or such other means as in its discretion the Fire Department deems is appropriate under the circumstances.
- D. Any such ban shall specify an expiration date. The ban may be extended in the same manner as its original imposition and upon competent evidence that the fire danger continues.

SECTION 11. LIABILITY

A Person utilizing or maintaining an outdoor fire shall be responsible for all fire suppression costs and any other liability resulting from damage caused by the fire.

SECTION 12. RIGHT OF ENTRY AND INSPECTION

The Fire Chief, any authorized officer, agent, employee or representative of Valencia County, New Mexico may inspect any property for the purposes of ascertaining compliance with the provisions of this chapter.

SECTION 13. ENFORCEMENT

The Fire Chief or his/her designee, the County Sheriff, County Code Enforcement Officers or any authorized law enforcement officer is authorized to enforce the provisions of this chapter.

SECTION 14. EFFECTIVE DATE

This chapter shall take effect and be enforced thirty (30) days after its enactment and recording with the County Clerk as provided by law.

SECTION 15. PENALTIES

Any person found guilty of violating any provisions of this chapter shall be found guilty of a misdemeanor and fined not more than three hundred dollars (\$300.00) or imprisoned for a period of not more than ninety (90) days, or both fine and imprisonment.

SECTION 16. SEVERABILITY

Should any of this chapter be deemed unconstitutional or invalid by a court of competent jurisdiction, the remainder of this chapter shall not be affected.

SECTION 17. SEVERABILITY

Should any of this chapter be deemed unconstitutional or invalid by a court of competent jurisdiction, the remainder of this chapter shall not be affected.

SECTION 18. REPEAL OF CONFLICTING ORDINANCES OR RESOLUTIONS

Valencia County Resolution 2006-10, as well as all other Valencia County Ordinances or Resolutions relating to open burning which are in conflict with the above provisions, by the adoption of this Ordinance.

THIRD AMENDMENT TO CONTRACT NO. VCR-FY13-005

THIS THIRD AMENDMENT TO CONTRACT NO. VCR-FY13-005 (this "Amendment"), effective 12.18, 2013, is by and between the County of Valencia, Board of County Commissioners ("County") and Waste Management of New Mexico, Inc. ("Contractor"). Capitalized terms used in this Amendment and not otherwise defined shall have the meanings ascribed to such terms in the Agreement.

RECITALS

A. County and Contractor are parties to that certain Contract No. VCR-FY13-005 dated December 19, 2012 (the "Agreement"), under which Contractor is to perform certain solid waste services to the County and its residents. Contractor was to commence services under the Agreement on April 1, 2013;

B. On or about January 2, 3013, 2013, New Mexico Disposal, Inc. ("NMD") filed a with the County a "FORMAL PROTEST TO VALENCIA COUNTY'S RFP #: VCR FY 13-005 for Solid Waste Services";

C. On or about January 4, 2013, the County sent to Contractor a "Stop Work Direction for Contract #VCR-FY13-005";

D. On or about January 24, 2013, the County issued a denial of NMD's purported protest;

E. On or about February 15, 2013, NMD filed a "Notice of Appeal" with regard to the County's January 24, 2013 denial of NMD's purported protest;

F. On or about February 27, 2013, County and Contractor executed a First Amendment to Contract No. VCR-FY13-005 to delay commencement of Contractor's services until July 1, 2013;

G. On or about June 13, 2013, County and Contractor executed a Second Amendment to Contract No. VCR-FY13-005 to delay commencement of Contractor's services until January 1, 2014; and

H. The parties wish to further amend the Agreement to delay commencement of the Contractor's services, as provided below.

AGREEMENT

NOW, THEREFORE, in consideration of the mutual covenants and promises contained herein, the receipt and sufficiency of which are hereby acknowledged, the parties mutually agree as follows:

1. Section 3 of the Agreement is hereby replaced in its entirety with the following (changes indicated in underline and ~~strikethrough~~):

Term. This Agreement shall commence on the Effective Date and continue, unless terminated pursuant to Section 4, until eight (8) years from the Commencement Date. The Commencement Date, which shall be ~~January 1, 2014 or such other date agreed upon in writing by the parties~~ ~~the earlier of (i) 100 days from the date on which a judgment on the merits is issued in New Mexico Disposal, Inc. v. Valencia County, Case No. D-1314-CV-00206 (13th Jud. Dist. Ct.), or (ii) 100 days from the date on which the County lifts the Stop Work Direction pursuant to its January 4, 2013 letter to Contract,~~ is the date on which Contractor shall commence services hereunder. In accordance with Section 13-1-150 NMSA 1978, the term of this contract shall not exceed eight (8) years from the Commencement Date under any circumstances.

2. Except as otherwise provided in this Amendment, all other terms and provisions of the Agreement shall remain in full force and effect.

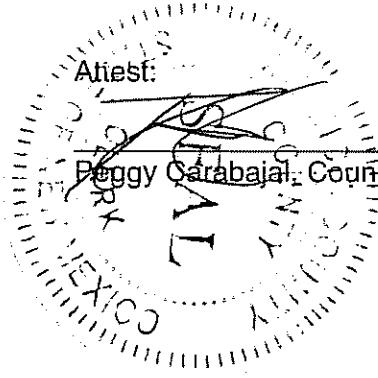

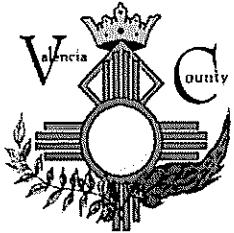

AMENDING VALENCIA COUNTY ORDINANCE 2010-01 THE SOLID WASTE MANAGEMENT ORDINANCE

RECITALS

- A. On May 19, 2010 the Board of County Commissioners of Valencia County adopted Ordinance 2010-01, the Solid Waste Management Ordinance, for the purpose of preserving the health, safety, welfare and convenience of the inhabitants of the county, and to preserve and improve the environmental quality of the county.
- B. Ordinance 2010-01 authorized a program for the collection of solid waste by providing for residential and commercial solid waste collection; defining types of services, providing authority for establishing collectors fees, establishing the procedure for selecting residential and commercial haulers; defining the minimum standards for collecting and disposing of solid waste; establishing the responsibilities of residents, businesses, contractors and the county; defining violations and penalties; and defining the status of existing contractor(s).
- C. The Board of County Commissioners has determined that the insurance requirements set forth in Chapter 50, Section 33 of the Solid Waste Management Ordinance, as codified, is inconsistent with industry standards and therefore places an undue burden on haulers without providing any additional benefit for the protection of the County or its residents.
- D. It is the intent of this amended to modify the insurance requirements to be consistent with industry standards thereby alleviating the burden on the haulers while continuing to adequately protect the County and its residents.

NOW, THEREFORE, IT IS ORDAINED AS FOLLOWS:

1. Incorporation of Recitals. The foregoing recitals are incorporated by reference as a material part of the Ordinance Amendment as if the same were set out completely in the Ordinance Amendment.

2. Amendment. Ordinance 2010-01 shall be amended as set forth in this instrument, and, except as expressly amended by this instrument, shall remain in full force and effect as written.

3. Amendment to Chapter 50 Section 33, as codified. Paragraphs A, B & C of Chapter 50, Section 33 of the Solid Waste Management Ordinance, as codified, is deleted in its entirety and the following paragraphs A & B are substituted in its place:

§ 50.33 PROOF OF INSURANCE BY THE RESIDENTIAL/COMMERCIAL CONTRACTOR (HAULER).

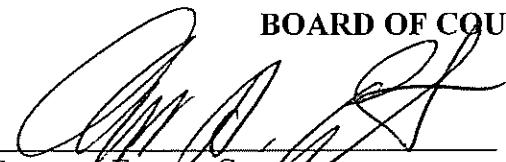
Section (A) All contractors/haulers shall provide the county with a certificate of insurance naming Valencia County as an additional insured. The contractor shall provide workers compensation insurance for its employees, unless exempted by State or other prevailing statute. The contractor shall also hold general liability insurance coverage in the amount of \$1,000,000, at minimum. The insurance coverage shall be for accidents or occurrences that cause bodily injury, death, or property damage to any member or citizen of the general public resulting from any of the collection activities under this chapter, or any activities contemplated in any contract or agreement for the collection of solid waste and/or recyclables

Section (B) Any business or person engaged in the collection of solid waste and/or recyclables in unincorporated Valencia County shall file with the County Clerk a copy of its certificate of insurance, as mandated in section (A) above, and shall file with the County Clerk an affidavit, indicating that adequate arrangements have been made to notify the County Manager, in writing, not less than 30 days prior to cancellation of any such policies thereof.

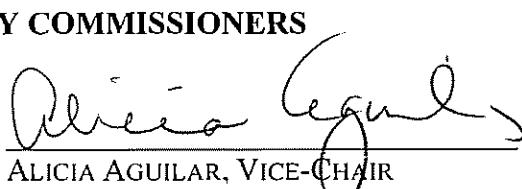

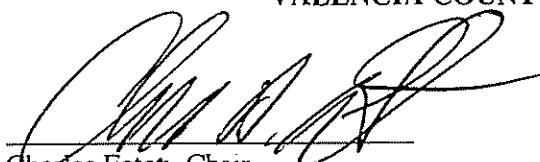
In recognition of the above, the Manager's Office request this action be officially recorded in the minutes of the regular County Commission meeting before which body this matter came.

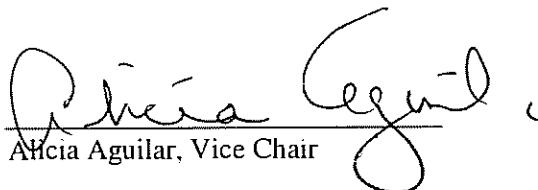
